EXECUTIVE SUMMARY

History

The Palm Beach County Department of Community Services is responsible for the Financially Assisted Agency Program (FAA). The program was established in the early 1980's and approximately \$13,000,000 million dollars are allocated to local agencies through the formal RFP process.

Department staff, the Citizens Advisory Committee on Health & Human Services (CAC), service agencies, community partners and the public have input into the FAA process prior to the BCC having final funding disposition. The mission of the CAC is to "Assist the Board of County Commissioners in the assessment of need, planning, implementation and evaluation of the System of Care, as defined in <u>The Health and Human Services Element of the Palm Beach County Comprehensive Plan.</u>" The Committee recommends service priorities prior to the RFP process. They base these recommendations on community assessments and other information gathering processes. The CAC incorporates <u>The Health and Human Services Element</u> of the Comprehensive Plan into its' decision-making process. The purpose of <u>The Health and Human Services Element</u> is "To assist in the development of an infrastructure to ensure availability of health and human services sufficient to protect the health, safety and welfare of Palm Beach County residents." Additionally, <u>The Report of Health & Human Services In Palm Beach County - Based on Key Community Indicators</u> is utilized as a guide to making decisions, promoting community participation and providing a statement for those involved in health and human services.

Schedule

The process consisted of, two (2) public forums were held (February 6, 2015 & February 24, 2015) and the Citizens Advisory Committee on Health & Human Services discussed Domestic Abuse/Sheltering at their Regular Committee meeting on February 12, 2015.

Individuals attending the public forums were requested to respond to three (3) questions *(Attachment D)* that related to the Domestic Abuse/Sheltering FAA Service Category. The following support documents were available to participants:

Staff Recommendation for FAA RFP Priorities (FY2015/2016)

Staff recommendations for the Domestic Abuse/Sheltering FAA RFP (2015/2016) are as follows:

<u>Domestic Abuse/Sheltering</u>: Programs and services in this category should address outcomes and performance measures that demonstrate positive change toward the goal of assisting the victims of domestic violence. This could include: Community-based domestic violence and runaway services; identifying and improving service quality and performance; promoting public awareness and education which lead to prevention; and providing information to the public regarding domestic violence and runaways and available services.

Expanded resources to address some unmet needs in the Domestic Abuse/Sheltering service category and that the current mix of services reflect the highest priority needs of the continuum of care. Services aimed at maintaining the current shelter beds and services to high risk youth in need of shelter because of domestic violence or tertiary prevention should be top priority if funding is flat or decreased. Emphasis for additional funding should address targeted public awareness and education projects that will lead to long term prevention. Use of evidence based programs similar to those implemented by the Center for Disease Control (CDC) and expansion of PBSO models for public awareness should receive high concentration.

Domestic Abuse/Sheltering Definitions

Domestic violence – means any assault, aggravated assault, battery, aggravated battery, sexual assault, sexual battery, stalking, aggravated stalking, kidnapping, false imprisonment or any criminal offense resulting in physical injury or death of one family or household member by another family or household member.

Family or household member – means spouses, former spouses, persons related by blood or marriage, persons who are presently residing together as if a family or who have resided together in the past as if a family, and persons who are parents of a child in common regardless of whether they have been married. With the exception of persons who have a child in common, the family or household members must be currently residing or have in the past resided together in the same single dwelling unit.

Domestic Abuse/Sheltering Goals

<u>Goal #1</u>: Develop a county-wide protocol for law enforcement to standardize the response to domestic violence investigations to ensure the victims countywide receive the same level of service.

<u>Goal #2</u>: To continue to identify new avenues for education and public awareness campaigns

<u>Goal #3</u>: Continue to collect, analyze and report statistical data on domestic violence that would assist in current and future responses to domestic violence.

<u>Goal #4</u>: Collaborate with the PBC Domestic Fatality Review Team and provide funding so that accurate data collection tools could be used county-wide to assist in the review of domestic homicides and the prevention of future homicides

<u>Goal #5</u>: Collaborate with the two certified shelters within Palm Beach County to assess the current needs to include the potential of increasing the number of beds available to victims.

<u>Goal #6:</u> Develop a county-wide protocol to standardize the response to youth domestic violence to ensure youth countywide receive the same level of diversion opportunities and wraparound services.

Notes:

Minimal differences in criteria, unmet needs, and services that were posted in the FAA FY2013 RFP were expressed during Domestic Abuse/Sheltering public forums. Review "Summary Results of Responses to Questions – Public Forums" (Attachment E) for additional details.

The FAA RFP (FY2013) noted five (5) Goals for Domestic Abuse/Sheltering (Attachment K). Each Goal stipulates Action Steps, a time frame, proposed partners, annual cost and funding status information.

Public Forum participants unanimously concur with staff recommendations for Domestic Abuse/Sheltering as listed above.

The results of the Domestic Abuse/Sheltering public forums are intended to be used in final Financially Assisted Agency (FAA) funding decisions. Additionally, it is meant to be something that will be part of ongoing dialog with the Board of County Commissioners and Citizens Advisory Committee on Health & Human Services to help the County know the general direction of future funding.

ATTACHMENT "A"

FINANCIALLY ASSISTED AGENCIES RECOMMENDATIONS FY 2013:

This report indicates the need for expanded resources to address some unmet needs in the Domestic Violence/Shelter services category; however, we feel the current mix of services reflects the highest priority needs of the continuum of care. Services aimed at maintaining the current shelter beds and services to high risk youth in need of shelter because of domestic violence or tertiary prevention should be top priority if funding is flat or decreased.

We feel the request for proposals should allow for applicants to address the recommendations in this report in years two (2) and three (3) of the funding request should additional funding become available. Emphasis for additional funding should address targeted public awareness and education projects that will lead to long term prevention. Use of evidence based programs similar to those implemented by the Center for Disease Control (CDC), expansion of PBSO models for public awareness or other mentioned in the report should receive higher consideration.

Answer: Yes. There was consensus that there are gaps and unmet needs in the following areas:

- 1. Youth offenders (gaps in services)
- 2. Juveniles (gaps in services)
- 3. Prevention (gaps in services)
- 4. Transitional housing increase transitional housing by prioritizing domestic violence as an issue to qualify for housing and utility services
- 5. Streamline the process and/or change polices to increase access to housing and continuum of care for victims of domestic violence
- 6. There is a gap and need for services for pregnant women and women with small children
- 7. Additional emergency funds (financial assistance) for individual financial issues (rent/utilities/food)
