- 1. Call to order/roll call Daniel Gibson opened the meeting. Attendees introduced themselves. Agency roll call was taken to establish a quorum.
 - a. Two new agencies were welcomed as members of the HHA
 - i. St. George's Center, Inc.
 - ii. PBC School District
- 2. Approve minutes from previous meeting Minutes from the Feb. 23rd meeting were unanimously received.
- 3. Emergency Solutions Grant (ESG) Jo Miller and Georgiana Devine reported that the following motions were approved by the executive committee.
 - a. Apply 100% of the *second allocation* of FY '12, ESG money to Rapid Re-Housing.
 - b. Apply 60% of ESG funding for Emergency Shelter and Homeless Prevention and 40% for Rapid Re-Housing For FY '12-'13.
 - c. An application will be developed and released for providers to apply for the approved activities. A Homeless Continuum of Care Grant Review Committee will be formed by 4/9/12. The Committee may include up to 7 members and will be composed of agencies that will not apply for the funds. One of the seven will be a formerly homeless person. The members of the CoC gave a unanimous approval of the executive committee's recommendations by a show of hands. Moved this sentence.

- e. Unmet Needs Kathleen Herd reported that the final draft of a survey is almost complete and will be presented at the April Executive Committee Meeting.
