Meeting Minutes

- 1. Call to order at 2:03pm /roll call/introductions Pam O'Brien (Chair) opened the meeting. Introductions conducted and agency roll call was taken to establish a quorum.
- 2. Approval of Minutes Pam O'Brien (Chair), motion was made by: Alex Stevens to accept the September 2013 minutes and second by: E. Jo Miller, Motion carried unanimously. Corrections made to comments under new business by Alex of Catholic Charities (Alex did not commend Daniel Gibson) and spelling of Terris Collins name was corrected.
