The Re-Entry Employer Reception was held on Monday, November 23, 2009 at the West Palm Beach City Hall from 5:00 pm to 7:00 pm. The Reception was hosted by County Commissioner Priscilla A. Taylor and the Palm Beach County Criminal Justice Commission's Weed and Seed Program and was sponsored by Andrew Luchey of A & Associates. After responses from 600 participants at the Re-Entry Transition Fair in September, it was recognized that there was a need to get more employers involved. The goal of the Employer Re-Entry Reception was to educate local businesses and employers of the federal and local benefits to hiring ex-offenders. Business owners from throughout Palm Beach County were invited to come out and listen to guest speakers such as Dr. Gary Dennis and Chief Judge Peter Blanc as they identified the benefits of hiring previously incarcerated individuals. *Continue on page 2*

Re-Entry Employer Reception

The evening began with a warm welcome from Commissioner Priscilla A. Taylor who showed her true passion for the reentry effort. Commissioner Taylor was followed by Palm Beach County Public Defender Carey Haughwout and Chief Judge Peter Blanc who spoke on the local benefits of helping ex-offenders find employment. Key note speaker Dr. Gary L. Dennis, Senior Policy Advisor for Corrections Department of Justice, came from Washington D.C. to speaker with the local business owners regarding benefits on the federal level as well as the Second Chance Act. Gary Hawkins and Dough Saenz from Workforce Alliance spoke about the Federal Bonding Program and WOTC funding. At the end of the reception, Palm Beach County Weed and Seed Coordinator Rosalind Murray gave the closing remarks emphasizing the importance of the reentry issue. This event was an effort to promote employer participation in the next Re-Entry Transition Fair as well as increasing awareness of reentry. Graffiti Mural Project

Lead artist Peter Agardy helped youth at the Boynton Beach Youth Empowerment Center (YEC) express their artistic abilities in a creative way. Agardy was exposed to graffiti at a young age and soon expressed his talent while attending the Dreyfoos School of the Arts in West Palm Beach. His passions for graffiti lead him to projects such as The Graffiti Mural Project. The Graffiti Mural Project which started in September took place at the Sara Sims Racquet Ball Court in Boynton Beach. The goal of the project was to steer youth away from illegal graffiti, while allowing them to participate in art. Peter Agardy, alongside other artist(Doug Hoekzema, John Griffin, Jermaine Johnson, Angel Mir, and Chan Shepard), helped five youth create a 15'x60' wall which represents the progression of African American music from the blues to R&B, including modern day music styles such as scratching. The artists decided to use bright colors such as blues and yellows to capture Florida's sunsets and oceans. The unveiling of the wall took place on Thursday, December 17, 2009 and included entertainment and light refreshments. Agardy quotes, "I think everyone involved in this project learned a lot, from the kids involved in the painting sessions, to the community's passerby's, to us the artists and everyone in between." Citizens Criminal Justice Academy Graduation



The 22nd Criminal Justice Academy Graduation took place 6:00 pm on December 17, 2009 at the Palm Beach County's Sheriff's Office. A total of 48 graduates were presented with a Certificate of Recognition for their participation in the Academy. The keynote speaker and presenter of certificates was Barbara Cheives, Chair of the Criminal Justice Commission. Barbara Cheives was first introduced to the Criminal Justice Commission (CJC) through the Citizens Criminal Justice Academy. Katherine Hatos, CJC staff, coordinated the classes and expressed that the highlight of the course was the CERT's (Corrections Emergency Response Team) and the

tour of the Medical Examiner's Office. Carol Trebatch a graduate of the Academy said that her most high-lighted moments were the prison tour, the basement of the court house, and the 911 call center. In order to sign up for the Citizens Criminal Justice Academy, participants must register online at the Criminal Justice

Commission's website, and must be at least 18 years old to enroll. This experience provides citizens of the county with general knowledge of how the criminal justice system works. The course covers subjects such as law enforcement at the local, state and federal levels, criminal courts, corrections, and juvenile justice. Aside from the classroom atmosphere, attendees will be able to participate in educational tours of the Palm Beach County Sheriff's Office 911 Center, main courthouse, Palm Beach County Jail, Juvenile Assessment Center, Eagle Academy, and the Medical Examiner's office.

Youth Empowerment Centers Give Thanks


