I. Welcome and Opening Comments, April Bristow, Chair

CJC Executive Director introduced the new chair, April Bristow, General Counsel for the 15th Judicial Circuit. Ms. Bristow welcomed the attendees and convened the meeting.

II. Roll Call and Introduction of Guests

Members and guests signed in the chat box for attendance in lieu of roll call and introductions.

III. Role of the Court System Task Force, April Bristow and Regenia Herring

Ms. Bristow and Ms. Herring discussed the role of the reconstituted Court System Task Force, indicating that it would take direction from the Criminal Justice Commission and focus its efforts initially on the MacArthur Foundation Safety and Justice Challenge (SJC). Ms. Bristow commented that she would like to see the task force focus on fact finding and recommendations that can be realistically attained. She would like to see case process efficiency examined in a manner consistent with the goals of the SJC.

IV. CJC Update, Regenia Herring

Ms. Herring indicated that the CJC has made some significant gains through its work, but that some SJC proposals were not adopted. She stated that it would be beneficial if more progressive proposals and actions were developed by Palm Beach County.

V. Safety and Justice Challenge Update, Regenia Herring, Bert Winkler and Jacqueline Jackson

Bert Winkler and Jacqueline Jackson presented updates on various aspects of SJC.

- The text reminder system is ongoing. The appearance rate for defendants receiving text reminders is 97%. Defendants on SOR are now receiving text reminders for Pretrial Services appointments. DOC Probation is working with our vendor Uptrust to develop a similar system.
- 21 participants have now been housed in the PalmFUSE project with a goal of 25. Only two have been rearrested. In the two year period prior to being housed, the 21 participants were booked 103 times for a total of 1,932 bed days at a cost of \$250,820 to the county (\$135/day). The PBC Continuum of Care will continue to use frequent utilizer data to prioritize homeless individuals for housing.
- The Public Defender continues its work with its Social Services Coordinator obtaining placements for pretrial clients with community services providers to reduce length of stay in jail.
- Pretrial Services continues to provide indigent clients with bus passes for court hearings and related appointments as well as funding for required drug screens.
- Two new programs are being developed. The first will seek to reduce recidivism
 for individuals cycling through the jail on low level offenses who plead guilty at
 First Appearance, receive sentences of ten days or less and have behavioral
 health challenges. Participants would receive a brief assessment at the jail and
 then be connected to appropriate services in the community. The second will
 seek to improve pretrial success for defendants on SOR by making peer mentors
 available to them.
- Additional funding may be available in 2022 from the MacArthur Foundation in the form of a Sustainability Grant.

• A Memorandum of Understanding has been ratified between the CJC and the Florida State University School of Criminology and Criminal Justice for future research projects.

VI. New Business

A. Preliminary Report on the Impact of Judicial Administrative Order during COVID-19 that Reduced Bonds for Some Third Degree Felonies from \$3,000 to \$1,000-Jennifer Copp, Florida State University

Dr. Jennifer Copp of Florida State University (FSU) presented preliminary findings regarding the administrative order (AO) referenced above. A complete report will be issued by the end of the year. The preliminary findings were consistent with the AO achieving its objective of reducing overall bond amounts on certain third degree felonies, leading to higher rates of pretrial release and less time spent in jail during the pandemic. FSU is studying the data on the individuals released pursuant to the AO to determine if there was a corresponding effect on the rates of failures to appear (FTA) and recidivism. Comparing these individuals to those with similar third degree felony charges who were released prior to the issuance of the AO, it was found that FTAs dropped from 5% (pre-AO) to less than 2% (post-AO). The recidivism rate also dropped for the post-AO group, from 15% to 9%.

B. Discuss Testing Unsecured Bond Option with Evaluation-Jennifer Copp

Dr. Copp indicated that a pilot project was going to be developed, in consultation with stakeholders, that would create an option of an unsecured bond for a specific subset of defendants, who could then be compared to individuals released on money bond in regard to pretrial success.

C. CJC Executive Committee Directed Staff to Research Current Bond Forfeiture Rates and Collection Process for Further Review-Regenia Herring

Ms. Herring informed the members that the CJC Executive Committee has directed staff to research and report on the rates and collection process of bond forfeitures.
