Before me, the undersigned Notary Public, personally appeared the individual whose name and address is shown above and, after being duly sworn, deposes and says:

1. I have read the Florida Administrative Code subsection 12A-1.007(10), and section 212.05, Florida Statutes; and
2. I am not a resident of the State of Florida and do not make my permanent place of abode in Florida at the time of taking delivery of the aircraft designated above; and
3. I am not engaged in Florida in any employment, trade, business or profession in which the designated aircraft will be used; and
4. If I represent a corporation, it has no officer or director who is a resident of, or makes his permanent place of abode in, Florida; and
5. If I represent an artificial entity other than a corporation, it has no individual vested with authority to participate in the management, direction or control of the affairs of the entity who is a resident of, or makes his or her permanent place of abode in, Florida; and
6. I hereby agree to provide the Florida Department of Revenue within 90 days of the date of purchase listed above written proof that the designated aircraft was licensed, registered or documented outside of Florida; and
7. I hereby agree to provide the Florida Department of Revenue within 30 days of the aircraft departing Florida invoices for fuel, tie-down charges, or hangar charges issued by out-of-state vendors, suppliers or servicers, or other credible documentary evidence which specifically identifies the designated aircraft, including the FAA registration number; and
8. I claim exemption under section 212.05(1)(a)2, Florida Statutes, from Florida sales and use tax on the purchase of the designated aircraft for the following reason:
 - Aircraft will be removed by me or by my designated agent from the State of Florida within 10 days of the date of purchase; or
 - Aircraft is to be repaired or altered and will be removed from the State of Florida by me or by my designated agent within 20 days after completion of the repairs or alterations, consistent with section 212.05, F.S.
