The Aquatics Division of Palm Beach County Parks and Recreation Department would like to invite your camp to enjoy one of our traditional aquatic facilities during the 2024 summer season.

Camp Sessions will be as follows: **11:00am-12:30pm** • **12:30-2:00pm** • **2:00-3:30pm**

How to Purchase Tickets and Reserve Space for a Camp – Please read carefully:

- Purchase Advance Admission Tickets at discount: <u>Payment required at time of reservation!!</u>
 - Sold Starting: <u>April 2 until May 10</u> on a first come first serve basis. Must **Pay** on day of reservation.
 - <u>**Pre- Registration Required:**</u> (See Reservation procedures on the next page)
- Regular Reservations: Reserve and pay on Day 1 of visit or before
 <u>Available Starting</u>: <u>April 16</u> on a first come first serve basis.
- Regulations: Tickets are only valid for the 2024 summer season. No refunds will be given for unused tickets or inclement weather. In the event your visit is canceled due to inclement weather, your camp may be re-scheduled based upon available dates and times.

> <u>Payment Options</u>:

There are three options to pay for your Summer Camp Visit.

- Company/ organization check: (payable to the Board of County Commissioners -BOCC). Check payment and completed reservation form may be submitted in person or by mail. Please see reservation procedures below for Santaluces. Payments may also be mailed.
- 2. Credit Card: (Visa, MasterCard, American Express, or Discover). Credit Card payment and completed reservation forms may be submitted in person or via fax or email. A photocopy of the credit card must be submitted if the reservation is made via fax or email. (Credit Card Authorization form is attached to this packet)
- 3. Cash: **ONLY** accepted in person, and will require an additional form be filled out upon reservation for qualified Tax Exempt organizations.

> Admission Fee's:

Advance Reservation: Sold April 2- May 10

- <u>Lake Lytal only</u>: \$3.28 + 7% tax
- <u>Aqua Crest, North County & Santaluces</u>: Youth \$2.85+7% tax

Regular Reservations: Accepted starting April 16

- <u>Lake Lytal</u>: Youth (ages 3-12) \$4.05 + tax, Adult (13 & older) \$4.60 + 7% tax
- <u>Aqua Crest, North County & Santaluces</u>: Youth \$3.45+ tax, Adult \$4.05+ 7% tax
- <u>Pioneer Park</u>: Youth and Adults \$1.00 (includes tax)

*Any summer camp claiming **Florida Tax Exempt** status must provide proof (Tax Exempt Certificate) at the time of payment. If payment is made via check or credit card, the name on the check or credit card must match the tax exempt certificate. If the names do not match a 7% sales tax will be applied to the total. (CC payments not in person will require a photo of the front of the card with all but the last 4 digits blacked out.)

Reservation Procedures:

Scan and email, fax or hand deliver a reservation form to the facility that you wish to visit. Confirmation will be returned via email. If there are any availability issues pertaining to dates, the facility staff will contact you via phone or email. <u>Please write clearly</u>.
