II. LMS Steering Committee Member update – Ronnie Heen, PBC DEM

- Current member count is at 15 people that includes 7 different municipalities
- Would like to add NPBCID as a special district
- Universities would like to be more involved; looking for someone from the education side that can be more involved in the SC; they would be helpful for the Watershed Management Plan. FAU is so involved in the WMP that it would be beneficial for even someone from FAU to be involved in the SC.
- Open to recommendations on anyone from the non-profit sector to join the SC (i.e.: Red Cross, Church Organization, United Way, Habitat from Humanity, etc..). Ideally the people who would be joining would like to participate
- Looking for a few people to join the LMS Revisions Committee. Just over two years from where the LMS is due for review. Would like to break the sections up and get them sections out to the members for review.
