**ORDER GRANTING PSYCHOLOGICAL EVALUATION**

Payment shall be made by cashier's check, money order, or other certified funds, made payable to the Board of County Commissioners of Palm Beach County, and delivered by hand or mail to the Court Psychology Office at the address below. If payment is not received within 10 days, the Court Psychology Office will notify the Court. If the parties settle their dispute prior to the completion of the psychological evaluation, they must immediately notify Court Psychology Office in writing. If the evaluation process has started, there will be no refund. Services rendered after the completion of the psychological evaluation (depositions / testimony / etc.) will be charged at the rate of \$150.00 per hour (\$300.00 in advance to cover prep/ and 1 hour of testimony)
