## RESOLUTION CORRECTING RESOLUTION R-2014-1646 (CONTROL NO. 2006-00397) RESOLUTION APPROVING ZONING APPLICATION OF Engineering and Public Works Department Minto West TTD APPLICATION CRB-2014-02294

WHEREAS, Engineering and Public Works Department, petitioned the Palm Beach County Board of County Commissioners on December 4, 2014 for a Corrective Resolution to add a portion of Engineering Condition 9 omitted from the Resolution R-2014-1646; and,

WHEREAS, Resolution R-2014-1646, adopted on October 29, 2014 confirming the action of the Board of County Commissioners inadvertently contained an error in Engineering Condition E.9 of Exhibit C; and,

WHEREAS, Engineering Condition E.9 of Exhibit C of Resolution R-2014-1646 should have read as shown as follows:

- 9. No Building Permits for more than 3,000 dwelling units east of Seminole Pratt Whitney Road shall be issued until:
  - i. The Property Owner has connected the second east/west collector roadway (Persimmon Boulevard) from Seminole Pratt-Whitney Road east through the site to the existing east/west roadway network east of the project and the roadway has been completed and accepted. Such roadway shall be constructed as per Palm Beach County standards; or
  - ii. The Property Owner makes a \$9,000,000 payment to Palm Beach County. If and when this connection is ultimately made, such payment shall be credited towards future proportionate share payments and shall be impact fee creditable.
  - iii. <u>Notwithstanding the foregoing, no connection of Persimmon Boulevard shall be</u> <u>made to 140<sup>th</sup> Avenue prior to the issuance of the 2700<sup>th</sup> dwelling unit permit.</u> (BLDGPMT: MONITORING - Engineering)

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

- 1. The foregoing recitals are hereby affirmed and ratified.
- 2. Engineering Condition- E.9 of Exhibit C of Resolution R-2014-1646 is hereby corrected.
