ZONING RESOLUTION NO. R-72-91

MODIFYING THE DISTRICT BOUNDARIES

ADOPTED February 17, 1972

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, in regular session assembled this the 17th day of February 1972, adopted as an Amendment to Zoning Resolution No. 3-57, pursuant to the authority vested in said Commission by Chapter 57-1691, Special Laws of Florida 1957, Chapter 59-1686, Special Laws of Florida 1959, and Chapter 70-863, Special Laws of Florida 1970:

A parcel of land in Block 32, Palm Beach Farms Company Plat No. 13 in Sections 32 and 33, Township 44 South, Range 42 East as recorded in Plat Book 6, Page 99, more particularly described as Tracts 12 through 21, 44 through 48, 49 through 53, 76 through 80 and the North 324.44 feet of Tracts 81 and 82, plus the East 124.5 feet of the South 334.56 feet of Tract 82, all of Tract 83 and the North 285.71 feet of Tract 84 and the East 30.31 feet of Tract 84, all of Tract 85, all of Tract 108, the East 30.31 feet of Tract 109, all of Tract 110, the East 124.5 feet of Tract 111, less the East 130 feet of the North 330 feet of Tract 76 is hereby rezoned from A-1 Agricultural District to R-1 Single Family Dwelling District.
