## RESOLUTION APPROVING ZONING PETITION

Loveland, Agent, for a SPECIAL EXCEPTION TO ALLOW A CHURCH on a parcel of land in the Northeast 1/4 of Section 25, Township 40 South, Range 42 East, more particularly described as follows: the North 640 feet of the East 240 feet of the West 660 feet of the Northwest 1/4 of the Northeast 1/4 of Section 25, Township 40 South, Range 42 East, less the West 100 feet of the North 200 feet of the above described parcel of land. Said property located on the south side of County Line Road approximately 1200 feet west of Seabrook Road in an RS-Residential Single Family District, was approved as advertised, subject to the following special conditions:

- (1) Provide wider parking bays;
- (2) Provide for counterflow ingress and egress;
- (3) Provide for a fifty (50) foot road right-of-way from the centerline of County Line Road.
