RESOLUTION APPROVING ZONING PETITION

Childs, Agent, for the REZONING, HROM AG-AGRICULTURAL DISTRICT TO RS-RESIDENTIAL SINGLE FAMILY DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A PLANNED UNIT DEVELOPMENT on Tracts 40 through 47 and Tracts 56 through 53, Block 76, Palm Beach Farms Company Plat No. 3 in Section 17, Township 7 South, Range 42 East as recorded in Plat Book 2, page 53. Said 'operty located on the north side of Boca Raton Road West (S.R. 808) proximately .2 mile west of Florida's Turnpike, was approved as ertised subject to the following conditions:
