RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, and Chapter 70-863, Laws of Florida, Special Acts of 1970, is authorized and empowered to consider petitions relating to zoning; and

AND BARBARA R. CALDWELL for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO CG-GENERAL COMMERCIAL DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A PLANNED COMMERCIAL DEVELOPMENT INCLUDING AN INTERIM PACKAGE TREATMENT PLANT on the East 1/5 .of the Southeast 1/4 of the Northeast 1/4 of the Southeast 1/4 of Section 13, Township 46 South, Range 42 East, less the rightof-way for State Road No. 806 (Delray West Road) as recorded in Road Plat Book 3, page 27. Said property located on the north side of Atlantic Avenue (Delray West Road, S.R. 806) approximately one (1) mile east of Military Trail (S.R. 809), was approved as advertised, subject to the following special conditions:

> Prior to the issuance of any building permits, the developer shall convey to Palm Beach County, the additional right-of-way required to provide one hundred

(100) feet of right-of-way from the centerline of West Atlantic Avenue.

2. Developer shall provide a temporary left turn lane, on the west approach at the intersection of West Atlantic Avenue and the development's entrance.
