RESOLUTION APPROVING ZONING PETITION.

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, and Chapter 70-863, Laws of Florida, Special Acts of 1970, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 75-93 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 31 July 1975.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session 31 day of July, 1975 this , that petition No. 75-93, the petition of THOMAS J. WHITE by Sam Ogren, Jr., Agent, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO IL-LIGHT INDUSTRIAL DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A PLANNED INDUSTRIAL DEVELOPMENT, INCLUDING A WATER AND SEWAGE PLANT on a parcel of land more particularly described as follows: commencing at the Southwest corner of Section 36, Township 42 South, Range 42 East, Palm Beach County Florida; run thence North 0° 04' 00" West along the West line of Section 36, a distance of 1635.52 feet to the Point of Beginning of the herein described parcel (the North line of the Southwest 1/4 of Section 36, is assumed to bear East-West and all bearings herein are relative thereto); thence East, a distance of 190.00 feet; thence North 36° 07' 35" East, a distance of 185.71 feet; thence South 61° 04' 25" East, a distance of 217.08 feet; thence East, a distance of 70.00 feet; thence North 20° 10' 14" East, a distance of 261.01 feet; thence East, a distance of 450.00 feet; thence South 52° 02' 45" East, a distance of 317.06 feet;

thence South 23° 03' 05" East, a distance of 255.39 feet; thence North 84° 55' 13" East, a distance of 451.77 feet; thence North 67° 31' 47" East, a distance of 444.81 feet; thence North 0° 13' 43" East, a distance of 270.00 feet; thence East, a distance of 300.00 feet to the West right-of-way line of Military Trail (State Road 809), Said right-of-way line being 50 feet Westerly from the East line of the Southwest 1/4 of Section 36; thence North 0° 13' 43" East along said right-of-way line, a distance of 660.00 feet to the North line of the Southwest 1/4 of Section 36; thence West along the North line of the Southwest 1/4 of Section 36, a distance of 2615.40 feet to the Northwest corner of the SouthWest 1/4 of Section 36; thence South 0° 04' 00" East along the West line of Section 36, a distance of 1000.00 feet to the Point of Beginning; Containing 53.94 acres, more or less. Said property lying between Haverhill Road and Military Trail (S.R. 809) approximately 1/2 mile south of Dyer Boulevard, was approved as advertised subject to the following special conditions:

- Developer shall construct the following at Military Trail (S.R. 809) and the development's north entrance:
 - a.
 - b.
 - Right turn lane, north approach Left turn lane, south approach Left and right turn lane, west approach c.
 - Signalization when warranted.
- Developer shall construct the following at Haverhill Road and the development's north entrance:
 - Left turn lane, north approach
 - Right turn lane, south approach b.
 - Left and right turn lane, east approach c.
 - d. Signalization, if and when warranted.
- Developer shall construct the intersection and roadway improvements including signalization on the development's interior roadways as prescribed by the Traffic Impact Analysis (Exhibit #22) for the subject development.
- Developer shall dedicate the following rights-of-way from the centerline of the roads, to Palm Beach County:
 - Sixty (603 feet for Military Trail (S.R. 809)
 - b. Fifty-four (54) feet for Haverhill Road.
- In order to facilitate the construction traffic, the' Developer shall construct the required turn lanes prior to the construction of the roads which intersect with Military Trail (S.R. 809) and Haverhill Road.
