NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 28th day of August, 1975 , that petition No. 75-107, the petition of BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, by E.W. "Bud" Weaver, Chairman, for a SPECIAL EXCEPTION TO ALLOW AN INTERIM SEWAGE TREATMENT PLANT on a certain parcel of land lying in the Southeast 1/4 of the Northwest 1/4 of Section 27, Township 43 South, Range 42 East, being also a part of Tracts 5 and 6, Block 4, Palm Beach Farms Company Plat No. 3, as recorded in Plat Book 2, page 46, for convenience bearings cited herein are in the meridian of the right-of-way of the hereinafter described Sunshine State Parkway as described in Road Plat Book 2, page 88, said parcel of land being more particularly described as beginning at the point of intersection of a line parallel with and 320 feet Northerly from (as measured at right angles to)

the South line of said Tract 6, Block 4, Palm Beach Farms Company
Plat No. 3 with a line parallel with and 215 feet .Westerly from (as
measured at right angles to) the North-South quarter section line
of said Section 27 and from said Point of Beginning run by the following
numbered courses:

- 1. North 87° 49' 20" West, running along a line at right angles to the said North-South quarter section line of Section 27, a distance of 525 feet; thence...
- 2. North 2° 10' 40" East, running along a line parallel with and 740 feet Westerly from (as measured at right angles to) the said North-South quarter section line of Section 27, a distance of 344.32 feet, more or less, to a point in a line parallel with and 20 feet Southeasterly from (as measured at right anlges to) the Southeasterly right-of-way of that certain 325 foot wide right-of-way of said Sunshine State Parkway as said right-of-way is located on Road Plat Book 2, page 88, said Southeasterly right-of-way line being 100 feet Southeasterly from (as measured at right angles to) the survey line as shown on said Road Plat Book 2, page 88; thence...
- 3. North 41° 02' 16" East, running along the just described parallel line, a distance of 232.04 feet, more or less, to a point in a line parallel with and 525 feet Northerly from (as measured at right angles to) Course No. 1 as hereinabove described; thence...
- 4. South 87° 49' 20" East, running along the just described parallel line, a distance of

379.42 feet, more or less, to a point in' the above described line being parallel with and 215 feet Westerly from (as measured at right angles to) the North-South quarter section line of Section 27; thence...

5. South 2° 10' 40" West, running along the just described parallel line, a distance of 525 feet more or less, to the Point of Beginning;

Subject to rights-of-way, easements and/or reservations of record.

if any. Said property located southeast of Florida's Turnpike, approximately .3 mile south of Okeechobee Boulevard (S.R. 704) and approximately .5 mile west of Drexel Road in an AG-Agricultural District, was approved as advertised.
