as advertised subject to the following special conditions:

1. The installation of the perimeter landscape shall be commenced by October 1, 1975, and completed by December 1,

- 1975, or the following extension to September, 1976 shall be considered null and void.
- 2. Petitioner shall have until September, 1976, to complete the required conditions placed on Petition No. 74-109, with the exception of the perimeter landscape buffer as stated above.
