SMITH by Ronald Sales, Attorney for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO RS-RESIDENTIAL SINGLE FAMILY DISTRICT of a parcel of land more particularly described as follows: commencing at the Southwest corner of Section 20, Township 41 South, Range 43 East; thence Easterly along the South line of Section 20, a distance of 1083 feet to the centerline of Palmwood Road; thence North along said centerline, a distance of 772 feet to the Point of Beginning and the Southeast corner of parcel; thence Westerly and parallel to the Southerly line of Section 20, a distance of 700 feet; thence Northerly and parallel to the centerline of Palmwood Road, a distance of 330 feet; thence Easterly and parallel
