

RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 77-100 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on August 25, 1977.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 25th day of August, 1977, that petition No. 77-100 the petition of ROBERT C. HAEBIG by John R. Ahonen for D. H. Tharin Land Surveying, Agent, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO RE-RESIDENTIAL ESTATE DISTRICT of a parcel of land in the East 1/2 of Northwest 1/4 of Section 1, Township 44 South, Range 41 East, more particularly described as the North 1/2 of the following: From the Northwest corner of said Section 1, run Easterly along the North line of said Section 1, a distance of 1765.21 feet to the Point of Beginning of the tract of land hereinafter described; thence continue Easterly along the North line of said Section 1, a distance of 270 feet; thence Southerly parallel to the West line of said Section 1, a distance of 1616.07 feet, more or less, to a point in the North line of the tract of land described in Deed recorded in Official Record Book 169, page 29; thence Westerly along said North line a distance of 270 feet, more or less, to a point in a line running Southerly from the Point of Beginning parallel to the West line of said Section 1; thence Northerly along said parallel line, a distance of 1610.12 feet, more or less, to the Point of Beginning. Said property located on the south side of Acme Road, approximately .6 mile west of State Road No. 7 (U.S. 441), was approved as advertised.
