NOW, THEREFORE, BE IT RESOLVED BY THC BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session 25th day of , that petition August , 1977 77-107 the petition of FRED BERGHOF by William R. Boose, 111, Attorney, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO IL-LIGHT INDUSTRIAL DISTRICT of the South 300 feet of the West 160 feet of that part of Tract 37, lying North of the right-of-way line of State Road 80, said Tract 37 being in Block 6 of Palm Beach Farms Company Plat #3 in Section 33, Township 43 South, Range 42 East as recorded in Plat Book 2, pages 45 to 54, and a parcel described as: beginning at the Southeast corner of Tract 38, of the above described block, thence North along the East line of Tract 38, a distance of 300 feet to a point, then due West, a distance of 150 feet to a point, thence South 300 feet to the South line of Tract 38, thence East along the South line of Tract 38, a distance of 150 feet to the Point of Beginning; subject to easements and rights-of-way of record. Said property located on the north side of Southern Boulevard (S.R. 80), approximately .3 mile east of Florida's Turnpike, was approved as amended to include

a Special Exception for a Planned Industrial Development subject to the following special conditions:

- 1. Petitioner shall reserve one hundred twenty (120) feet for the ultimate right-of-way for State Road

 No. 80 and shall not place any structure or do any work within the reserve area that will increase the market value of said area,
- 2. Petitioner agrees that should the Department of
 Transportation condemn additional right-of-way for
 State Road No. 80, he will not seek compensation for
 any additional structures within said condemned area.
