## RESOLUTION APPROVING ZONING PETITION

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session 25th day of this August, 1977 , that petition the petition of JAMES D. CASTO, THOMAS K. IRELAND AND No.77-79 BERNARD SCHONINGER, by Jan A. Wolfe, Agent, for the REZONING, FROM CN-NEIGHBORHOOD COMMERCIAL DISTRICT TO CG-GENERAL COMMERCIAL DISTRICT of the South 1/2 of Lot 3 and the North 1/4 of Lot 4 in Block 3 of Model Land Company's Subdivision of Section 12, Township 44 South, Range 42 East, known as Palm Beach Plantations, as recorded in Plat Book 10, page 20, less, however, that portion thereof which was conveyed to the County of Palm Beach by deed recorded in Deed Book 851, page 419, and that portion thereof which was conveyed to the State of Florida by deed recorded in Official Record Book 1104, page 345, also the North 1/2 of the North 1/2 of the Southeast 1/4 of the Southwest 1/4 of said Section 12, Township 44 South, Range 42 East, less and except the following described property: a certain parcel of land in the Southeast 1/4 of the Southwest 1/4 of said Section 12, Township 44 South, Range 42 East, more particularly described as follows: Beginning at the Point of Intersection of a line parallel with and 53 feet South of, measured at right angles to, the centerline of Forest Hill Boulevard, as same is shown on Plat recorded in Road Plat Rook 2, page 148, with the Westerly right-of-way line of Military Trail (S.R. 809) as same is shown on Plat recorded in Road Plat
