NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session 25th day of October, , that petition 1977 No, 77-136 the petition of the BOARD OF COUNTY COMMISSIONEHS, PALM BEACH COUNTY, FLORIDA, by Lake Lytal, Chairman, to reconsider the Rezoning and Special Exception Approval of Petition No. 77-46 to REZONE FROM AG-AGRICULTURAL DISTRICT TO RS-RESIDENTIAL SINGLE FAMILY DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A PLANNED UNIT DEVELOPMENT, granted to E.
