by Allen Doe, Agent, for a SPECIAL EXCEPTION TO ALLOW A CHURCH on a

parcel of land lying in Section 34, Township 40South, Range 41East,

being the South 1/3 of the Northwest 1/4 of the Southeast 1/4 of the Southeast 1/4 of the Southeast 1/4 of said Section 34, together with all of the Southwest 1/4 of the Southeast 1/4 of said Section 34; less, however, that partthereof lying South of the North line of a 200 foot right-of-way for State Road 706; subject to road easement for ingress and egress over the Easterly 30 feet thereof. Said property located on the north side of Indiantown Road (S.R. 706), approximately 200 feet south of 181st Court North in an AG-Agricultural District, was approved as advertised subject to the following conditions:

- Petitioner shall satisfy adequate fire flow requirements as determined by Jupiter Fire Control District #1.
