

RESOLUTION NO. R- 81-595

RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 81-64 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 23 April 1981; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. The proposal would be in harmony and compatible with the present and future development of the area concerned

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 12th day of May, 1981, that Petition No. 81-64 the petition of EDWARD GADINSKY by William R. Boose, III, Attorney, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO CG-GENERAL COMMERCIAL DISTRICT on a parcel of land lying in Section 14, Township 47 South, Range 42 East, being more particularly described

as follows: Commencing at the Southwest corner of said Section 14; thence North 00°00'27" East, along the West line of said Section 14, a distance of 671.47 feet to a point, said point being further described as being 60.00 feet West of the Westerly right-of-way line of St. Andrews Boulevard, and on the Northerly line of Parcel "C", as shown on the plat of Estada of Los Paseos PUD, as recorded in Plat Book 37, pages 110 and 111; thence continue North 00°00'27" East, along said West line of Section 14, a distance of 580.27 feet to a point on the Southerly right-of-way line of Boca Raton West Road (State Road No. 808); thence South 89°02'15" East, along said Southerly right-of-way line, a distance of 9.35 feet to the intersection with the arc of a circular curve to the right, whose radius point bears South 79°24'38" West from the last described point, said point being further described as being on the Westerly right-of-way line of St. Andrew's Boulevard; thence Southerly and Easterly, along the arc of said curve, along said Westerly right-of-way line having a radius of 2970.00 feet, an arc distance of 549.30 feet to the Point of Tangency; thence South 00°00'27" West, along said Westerly right-of-way line, a distance of 33.62 feet to a point on the Northerly line of said Parcel "C"; thence South 89°42'09" West, along said Northerly line of Parcel "C", a distance of 60.00 feet to a point on the West line of said Section 14 and the Point of Beginning. Said property located on the southwest corner of the intersection of Glades Road (S.R. 808) and St. Andrews Boulevard, was approved as advertised.

Commissioner Gregory, moved for approval of the petition. The motion was seconded by Commissioner Bailey, and upon being put to a vote, the vote was as follows:
