WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 482.5 of the Palm Beach County Zoning Code
Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petit ion No. 83-135 was presented to the Board of County Commissioners of Palm. Beach County at its public hearing conducted on 22nd December 1983; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendators of the various county review agencies and the recommendations of the planning Commission; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

- 1. The proposed development does not meet the intent of the Mandatory Performance Standards for Water Service, Sewer Service, Thoroughfares, or Environment.
- e. Provided all the suggested conditions of approval are complied with, the proposal makes acceptable provisions for drainage.
- **3.** The proposed density is not consistent with other properties and approvals in this area.
- 4. The proposal to extend suburban services to this area to serve requested densities is not consistent with the intent of the Urban Services Area provisions of the Comprehensive Plan.
