RESOLUTION APPROVING ZONING PETITION 82-69(B), Modification

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vestea in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 82-69(B) was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on the 31st October 1985; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and Zoning Code.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this the 31st of October 1985, that Petition No. 82-69(B) the petition of TANEN PROPERTIES By Nathan Tanen, Agent, to MODIFY THE FOLLOWING SPECIAL CONDITION PLACED ON ZONING PETITIOB NO. 82-69(A) APPROVED APRIL 26, 1984:

CONDITION NO. 2 STATES:

2. Within 6 months of Special Exception approval, the developer shall contribute eighteen thousand seven hundred ninety two dollars (\$18,792.00) toward the cost of meeting this project's direct and indentifiable impact. The money is to be used towards the Boynton Beach Boulevard Roadway Improvement Program. This project shall not be issued a building permit for the easterly office building until Eoynton Beach Boulevard is 4-laned from Lawrence Road to Oakwood

Lakes Boulevard.

REQUEST: TO MODIFY CONDITION NO. 2 TO READ:

Within 6 months of Special Exception approval, the developer shall contribute eighteen thousand seven hundred ninety two dollars (\$18,792.00)toward the cost of meeting this project's direct and identifiable impact. The money is to be used towards the Boynton Beach Boulevard Roadway Improvement Program. This project shall not be issued a Certificate of Occupancy for the easterly office building until Boynton Beach Boulevard is 4-laned from Lawrence Road to Oakwood Lakes Boulevard.

Said property located on the north side of Boynton Beach Boulevard (S.R. 804), approximately .2 mile east of Lawrence Road in a CG-General Commercial District was approved as advertised subject to the following conditions:

1. Condition #2 which presently states:

"Within 6 months of Special Exception approval, the developer shall contribute eighteen thousand seven hundred ninety two dollars (\$18,792.00) toward the cost of meeting this project's direct and identifiable impact. The money is to be used towards the Boynton Beach Boulevard Roadway Improvement Program. This project shall not be issued a building permit for the easterly office building until Boynton Beach Boulevard is 4-laned from Lawrence Road to Oakwood Lakes Boulevard."

is hereby amended to state:

"Within 6 months of Special Exception approval, the developer shall contribute eighteen thousand seven hundred ninety two dollars (\$18,792.00) toward the cost of meeting this project's direct and identifiable impact. The money is to be used towards the Boynton Beach Boulevard Roadway Improvement Program. This project shall not be issued a building permit for the easterly office building until the contract has been let for the reconstruction of Boynton Beach Boulevard from Lawrence Road to Oakwood Lakes Boulevard."

2. The petitioner shall present a notarized Affidavit of Disclosure at the Zoning Authority meeting.
