PLRN FOR A DAY CRRE CENTER CIND PRESCHOOL FACILITY, PREVIOUSLY APPROVED UNDER ZONING PETITION NO. 78-104, TO INCREASE THE BUILDING SQUARE FOOTAGE on the South 180 feet of the North 325 feet of the West 230 feet of the East 260 feet of the Southwest 1/4 of the Southwest 1/4 of Section 18, Township 44 South, Range 43 East. Said property located on west side of Gulfstream Road, approximately .1 mile south of Park Rvenue in an RM-Residential Multiple Family District (Medium Density) was approved as advertised subject to the following conditions:

- Prior to site plan certification the site plan shall be revised to reflect the following:
  - a. conformance with the minimum tree planting requirement
  - b conformance to the one (1) of three (3) alternative perimeter landscape strips separating the special exception use from the surrounding residential properties
  - c. a reduction in the total number of persons on site to 100 or less as per Health Department
  - d. all signage to be so as to not encroach any required landscape area.

- 3. The application and engineering plans, calculations etc. to construct well and/or septic tank shall be submitted to the Health Department prior to site plan approval.
- 4. Petitioner shall comply with the conditions of all previous approvals unless expressly modified herein.
