

RESOLUTION NO. R- 87-517

RESOLUTION RPPROVING ZONING PETITION 86-135, Rezoning

WHERECIS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements a5 provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No, 73-2 have been satisfied; and

WHEREAS, Petition No. 86-135 was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at its public hearing conducted on December 1, 1986 and WHERERS, the Board of County Commissioners ha5 considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning commission;

and

WHERERS, the developer shall retain the stormwater runoff in accordance in all applicable agency requirements in effect at the time of the permit application, However, at a minimum, this development shall retain onsite 85% of the stormwater runoff generated by a three (3) year-one hour storm per requirements of the Permit Section, Land Development Division. The drainage system shall be maintained in an acceptable condition as approved by the County Engineer. In the event that the drainage system is not adequately maintained as determined by the County Engineer this matter will be reviewed by the Code Enforcement Board for enforcement; and

WHERERS, the property owner shall pay a Fair Share Fee in the amount and manner required by the "Fair Share Contribution for Road Improvements Ordinance" as it presently exists or as it Petition No. 86-135 Page 1

may from time to time be amended. The Fair Share Fee for this project presently is \$1,045.00 per dwelling unit over 2,000 square feet; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations,

NOW, THEREFORE, BE IT RESOLVED BY THE BOFIRD OF COUNTY COMMISSIONERS OF PFILM BEFICH COUNTY, FLORIDA, assembled in regular session this <u>31ST</u> day of <u>March</u>, 19<u>87</u>, that: 86-135, the petition of FILEXFINDER W. FIND CECELIFI A. Petition No. FROM AR-AGRICULTURAL RESIDENTICIL LOSIEUICZ for a REZONING, DISTRICT TO RT-RESIDENTIAL TRANSITIONAL DISTRICT on a portion of the North 1/2 of the Southeast 1/4 of the Southeast 1/4 of the Northwest 1/4 of Section 13, Township 45 South, Range 42 East being more particularly described as follows: Begin at the Southeast corner of said North 1/2 of the Southeast 1/4 of the Southeast 1/4 of the Northwest 1/4 of Section 13, Township 45 South, Range 42 East; thence Westerly along the South line of said North 1/2 of the Southeast 1/4 of the Southeast 1/4 of the Northwest 1/4 for 342.00 feet; thence Northerly, along a line perpendicular to the last described course for 201.43 feet; thence Easterly along a line parallel with and 50.00 feet South of the North line of said North 1/2 of the Southeast 1/4 of the Southeast 1/4 of the Northwest 1/4 of Section 13, Township 45 South, Range 42 East, for 339.96 feet; thence Southerly along the East line of said North 1/2 of the Southeast 1/4 of the Southeast 1/4 of the Northwest 1/4 of Section 13, Township 45 South, Range 42 East for 281.16 feet to the Point of Beginning.
