

RESOLUTION NO. R-88 -129

RESOLUTION APPROVING ZONING PETITION 86-5
REVOKING A SPECIAL EXCEPTION FOR ZONING PETITION NO. 78-17
AND AMENDING RESOLUTION NO. R-78-226

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 4W2.5 of the Palm Beach County Zoning Code Ordinance No: 73-2 have been satisfied; and

WHEREAS, Petition No. S86-5 was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at its public hearing conducted on November 18, 1986 and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Petition No. S86-5 (Regarding Zoning Petition No. 78-17, Resolution No. R-78-226), The Petition of the Board of County Commissioners, by Karen T. Marcus, Chairman, to Revoke a Special Exception for a Planned Unit Development, on Tracts 4, 5, 6, 7, 8, 9, 16, 17, 18, 19, 23 and 21, Block 17; the South 1/2 of Tracts 32 and 33, and Tracts 44, 45, 46 and 47, Block 10, Palm Beach Farms Company Plat No. 3, in Sections 6 and 7, Township 44 South, Range 42 East, as recorded in Plat Book 2, pages 46 and 47, located on on the east side of State Road 7, and on the north and south side of Dillman Road, was approved as advertised.

A motion to approve Petition No. S86-5 was offered by Commissioner Adams, who moved its adoption. The motion was seconded by Commissioner Owens, and upon being put to a vote, the vote was as follows:
