AND AMENDING RESOLUTION NO. R-78-1261

WHEREAS, the Board of County Canmissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY CONMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Petition No. \$86-6 (Regarding Zoning Petition No. 78-184, Resolution No. R-78-1261), The Petition of the Board of County Commissioners, by Karen T. Marcus, Chairman, to Revoke a Special Exception for a Planned Unit Development, on Tracts 43 and 64, less that part deeded to the State of Florida in Deed Book 1125, page 650, also less the South 30 feet of Tract 64; and Tract 50, less the West 30 feet thereof, and Tract 63, less the Nest 30 feet and the South 30 feet thereof, all in Block 11, Palm Beach Farms Company, Plat No. 3, in Sections 5 and 8, Township 44 South, Range 42 East, as recorded in Plat Book 2, page 46. Said property located on the North side of Dillman Road and on the West wide of Florida's Turnpike, located on the north side of Dillman Road, and on the west side of Florida's Turnpike, was approved as advertised
