RESOLUTION APPROVING ZONING PETITION S86-8
REVOKING A SPECIAL EXCEPTION FOR ZONING PETITION NO. 75-50
AND AMENDING RESOLUTION NO. R-75-404

KHEREAS, the Board of County Canmissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and Empowered to consider petitions relating to zoning; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Petition No. S86-8 (Regarding Zoning Petition No. 75-50, Resolution No. R-75-404), The Petition of the Board of County Canmissioners, by Karen T. Marcus, Chairman, to Revoke a Special Exception for a Planned Unit Development, of the North 3/4 of the East 1/2 of Section 35, Township 43 South, Range 41 East, Palm Beach County, Florida, lying North of the North right-of-way line of the West Palm Beach Canal, less the right-of-way of State Road No. 80, and subject to the right-of-way of Florida Power & Light Company, recorded in Official Record Book 80, pages 177-183, Fublic Records of Palm Beach County, Florida, located on the north side of Southern Boulevard, approximately 1,200 feet east of Royal Palm Beach Boulevard, was approved as advertised.
