RESOLUTION APPROVING ZONING PETITION 586-51
REVOKING A SPECIAL EXCEPTION FOR ZONING PETITION NO. 79-7
AND AMENDING KESOLUTION NO. R-79-182

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and annowered to consider petitions relating to zoning; and
