Marcus, Chairman, to revoke the Special Exception for additions to an existing Commercial New and Used Automobile Sales Lot ad Service Facility, on the Southwest 1/4 of the Southwest 1/4 of the Northeast 1/4 of Section 25, Township 43 South, Range 42 East, Less, however, the West 53 feet thereof and the South 20 feet thereof, on property located on the east side of Military Trail, approximately 0.4 of a mile south of Okeechobee Boulevard was withdrawn, without prejudice.
