NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA that: Petition No. S86-32 (regarding Zoning Petition No. 8W-131, Resolution No. R-80-1228), the petition of the Board of County Commissioners, s by Karen T. Marcus, Chairnan, for rezoning from CG-General Commercial Zoning District to RS-Single Family Residential Zoning District, on the West 200 feet of Block 21, Block 2, LAGUNA PARK NO. 1, in Section 8, Township 44 South, Range 43 East as recorded in Plat Cook 21, page 53, less the North 22.4 feet and less the West 17 feet thereof, located on the east side of Congress Avenue, approximately 100 feet north of Melaleuca Drive, was withdrawn, without prejudice.
