RESOLUTION APPROVING RECOMMENDATION OF STATUS REPORT NO. SR 89-112 TO AMEND CONDITIONS OF APPROVAL OF RESOLUTION NO. R-90-90-590 WHICH APPROVED THE SPECIAL EXCEPTION OF NATHAN SIEGEL PETITION NO. 89-112

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; .and

WHEREAS, systematic monitoring and review **of** approved zoning actions help implement the goals and objectives **of** the Comprehensive Plan.

WHEREAS, the notice and hearing requirements as provided for in Section 402.9 of the Palm Beach County Zoning Code have been satisfied; and

WHEREAS, pursuant to Section 402.9, Status Report SR 89-112 was presented to the Board of County Commissioners **of** Palm Beach County, sitting as the Zoning Authority, at a public hearing conducted on April 23, 1992; and

WHEREAS, the Board of County Commissioners, sitting as the Zoning Authority, has reviewed Status Report  $\mathbf{SR}$  89-112 and considered testimony presented by the applicant and other interested parties, and the recommendations of the various county review agencies; and

WHEREAS, Section 402.9 of the Palm Beach County Zoning Code authorizes the Board **of** County Commissioners, sitting as the Zoning Authority, to add or modify conditions **of** approval; and

WHEREAS, the Board **of** County Commissioners, sitting as the Zoning Authority, made the following findings **of** fact:

- 1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations; and
- 2. The new condition listed below requires this petition to develop more in conformity with current standards of development.

WHEREAS, Section 402.5 of the Zoning Code requires that the action of the Board of County Commissioners, sitting as the Zoning Authority, be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the recommendation of Status Report No. SR 89-112, amending Conditions of Approval of Resolution No. R-90-590, the Special Exception of Nathan Siegel, Petition No. 89-112, which granted a Special Exception to permit commercial, new and used, auto, truck, boat, motorcycle, mobile home, recreational vehicle sale and rental and repair facilities and lots (used car sales), on Lots 53 through 60, Block 27, Westgate Estates, Plat Book 8, page 38, lying in Section 30, Township 43 South, Range 43 East., being located on the northwest corner of the intersection of Westgate Avenue and Seminole Boulevard, in a CG-General Commercial Zoning District, is approved, subject to the following conditions:

- 1. The petitioner shall comply with all previous conditions of approval unless expressly modified herein.
- 2. By September **30**, 1992, the property shall submit and have

certified, a site plan which (1) complies to the maximum extent possible with the landscape code in effect at that time, and (2) complies with Section 500.13, "Commercial new and used motorcycles, auto, truck, boat, mobile home, recreational vehicles and rental and repair, facilities and lots" or equivalent section.of the Code in effect at time of approval.
