RESOLUTION AMENDING RESOLUTION NO. R-89-1160
RESOLUTION APPROVING ZONING PETITION OF
BERNSTEIN-GLADES ASSOCIATES, LTD.
PETITION NO. 85-95(B)

WHEREAS, **BERNSTEIN-GLADES ASSOCIATES, LTD.** petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority, on December 1, 1988 and December 29, 1988, respectively, for a REZONING FROM THE CG-GENERAL COMMERCIAL ZONING DISTRICT TO THE CS-SPECIALIZED COMMERCIAL ZONING DISTRICT; AND

WHEREAS, Resolution No. R-89-1160 adopted June 13, 1989, confirming the action of the Board of County Commissioners sitting as the final zoning authority on December 29, 1989, inadvertently contained an error in the legal description; and

WHEREAS, the legal description of Resolution No. R-89-1160 reads as follows:

"on a parcel of land lying on Tract 93, less the West 150.00 feet and less the South 40.00 feet and Tract 94, less the East 60.00 feet and less the South 40.00 feet of Block 77, Palm Beach Farms Company Plat No. 3, as recorded in Plat Book 2, Page 53, located in Section 10, Township 47 South, Range 42 East," ; and

WHEREAS, the legal description of said zoning resolution should have read:

on a parcel of land lying on Tract 93, less the West 150.00 feet and less the South 40.00 feet and Tract 94, less the East 60.00 feet and less the South 40.00 feet of Block 77, Palm Beach Farms Company Plat No. 3, as recorded in Plat Book 2, Page 53, located in Section ~~10~~ 18, Township 47 South, Range 42 East, .

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. The legal description of Resolution No. R-89-1160 is hereby amended.
