WHEREAS, MICHAEL DAVID & KAREN WELLS petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority, on August 1, 1991 and August 29, 1991, respectively, for the a REZONING FROM THE AR-AGRICULTURAL RESIDENTIAL ZONING DISTRICT TO THE RT-RESIDENTIAL TRANSITIONAL ZONING DISTRICT; and

WHEREAS, Resolution No. R-91-1715 adopted November 26, 1991, confirming the action of the Board of County Commissioners sitting as the final zoning authority on August 29, 1991, inadvertently contained errors in the legal description; and

WHEREAS, the legal description of Resolution No. R-91-1715 reads as follows:

"on a parcel of land lying South 140.52 feet of Tract 36, Block 32, of PALM BEACH FARMS COMPANY, PLAT #3, recorded in Plat Book 2, Pages 45 through 54; LESS the West 20.00 feet thereof, being located in Section 27, Township 43 South, Range 42 East,"; and,

WHEREAS, the legal description of said zoning resolution should have read:

on a parcel of land lying South 140.52 feet of Tract 36, Block 32, of PALM BEACH FARMS COMPANY, PLAT #3, recorded in Plat Book 2, Pages 45 through 54; LESS the West 20.00 feet thereof, being located in Section ~~27~~ 33, Township ~~43~~ 44 South, Range 42 East,.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. The legal description of Resolution No. R-91-1715 is hereby amended.

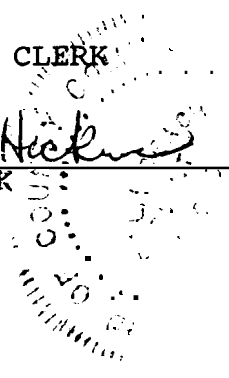
