

RESOLUTION APPROVING RECOMMENDATION OF
STATUS REPORT NO. SR 89-54.2
TO AMEND CONDITIONS OF APPROVAL OF RESOLUTION NO. R-90-65
WHICH APPROVED THE SPECIAL EXCEPTION OF
LAKE WORTH TURNPIKE ASSOCIATES
PETITION NO. 89-54

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, systematic monitoring and review of approved zoning actions help implement the goals and objectives of the Comprehensive Plan.

WHEREAS, the notice and hearing requirements as provided for in Section 5.8 of the Palm Beach County Land Development Code have been satisfied: and

WHEREAS, pursuant to Section 5.8, status Report SR 89-54.2 was presented to the Board of County Commissioners of Palm Beach County at a public hearing conducted on March 24, 1994; and

WHEREAS, the Board of County Commissioners has reviewed Status Report SR 89-54.2 and considered testimony presented by the applicant and other interested parties, and the recommendations of the various county review agencies; and

WHEREAS, Section 5.8 of the Palm Beach County Land Development Code authorizes the Board of County Commissioners to add or modify conditions of approval: and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations: and
2. The Palm Beach County Engineering Department recommends approval of the amended condition.

WHEREAS, Section 5.3 of the Palm Beach County Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the recommendation of Status Report No. SR 89-54.2, to amend Conditions of Approval of Resolution No. R-90-65, the Special Exception of Lake Worth Turnpike Associates, Petition No. 89-54, confirmed by the adoption of Resolution R-90-65, which granted a Special Exception for 1) a hotel, and 2) an existing public and private utility service (telephone exchange building and substation) on a parcel of land in Tract 64, Block 24, Palm beach Farms Plat No. 3, Plat Book 2, pages 45 to 54, described as follows: Beginning at the Southwest corner of said Tract 64, thence run Northerly along the West line of said Tract a distance of 660.00 feet to the Northwest corner thereof: thence run Easterly along the North line of said Tract 329.28 feet to a point; thence run Southerly a distance of 660.00 feet to a point in the South line of said Tract; thence run Westerly 329.62 feet along the South line of said Tract to the Point of Beginning: less State Road 802 right-of-way and less the following described portion: Commencing at the intersection of the West line of said Tract 64, Block 24, and the North right-of-way

line of State Road No. 802 (Lake Worth West Road), thence Northerly **along** the West line of said Tract 64, Block 24, a distance of 188.00 feet to the point of Beginning: thence continue Northerly, along the West line of said Tract 64, Block 24, a distance of 55.26 feet to a point: thence Easterly, making an angle with the preceding course of 80 degrees 27'25" measured from South to East, a distance of 25.02 feet to a point: thence Southerly, at right angles to the preceding course, a distance of 54.50 feet to a point: thence Westerly, at right angles to the preceding course, a distance of 15.86 feet to the Point of Beginning and less the South 239.34 feet to the East 182.00 feet thereof, being located on the northwest corner of Lake Worth Road and the Sunshine State Parkway (Florida's Turnpike) in the CG-General Commercial Zoning District, is approved, subject to the following conditions:

1. All previous conditions of approval continue to apply unless amended herein.
2. Condition number 19.b. which currently states:

No building permits for the subject site shall be issued after December 31, 1991.

Is hereby amended to state;

In order to comply with the mandatory traffic performance standards, no building permits shall be issued for the subject site after December 31, 1996.

Commissioner Newell moved for approval of the Resolution.


The Chair thereupon declared the resolution was duly passed and adopted this 24th day of March, 1994.
