RESOLUTION ABANDONING ZONING PETITION 86-38
ADMINISTRATIVE ABANDONMENT OF RESOLUTION R-86-1362
PETITION OF PALM BEACH COUNTY
BOARD OF COUNTY COMMISISONERS

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to **zoning**; and

WHEREAS, Zoning Petition 86-38 was presented to the Board Of County Commissioners at a public hearing conducted on May 22, 1986, and Resolution R-86-1362, approving this petition was adopted by the Board of County Commissioners; and

WHEREAS, the Zoning Director has determined that the request to administratively abandon the development order (Resolution **R86-1362**), as provided for in Article 5 (Development Review Procedures) of the Palm Beach County Land Development Code (Ordinance **92-20**), as amended, meets the requirements contained therein; and

WHEREAS, the Zoning Director has administratively abandoned the development order (Resolution R-86-1362), as provided for in Article 5 (Development Review Procedures) of the Palm Beach County Land Development Code (Ordinance **92-20**), as amended; and

WHEREAS, the Zoning Director presented the abandonment of the development order (Resolution R-86-1362), to the Board of County Commissioners for ratification on April 28, 1994; and

WHEREAS, Article 5, Section 5.3.D.9 (Action by Board of County Commissioners) of the Palm Beach County Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Resolution R-86-1362, approving Zoning Petition 86-38, the petition of Palm Beach **County** Board of County Commissioners for a Planned Industrial Development is hereby revoked.

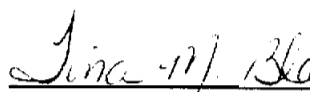
