RESOLUTION APPROVING RECOMMENDAT-"
STATUS REPORT NO. SR 84-12
TO REVOKE THE SPECIAL **EXCEPTI**.
FOR PROPERTY PREVIOUSLY GRANTED A SPECIAL EXCEPTION BY
RESOLUTION NO. R-85-257
APPROVING THE PETITION OF THOMAS DATORRE
PETITION NO. 84-121

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, systematic monitoring and review of approved zoning actions help implement the goals and objectives of the Comprehensive Plan; and

WHEREAS, the notice and hearing requirements as provided for in Section 5.8 of the Palm Beach County Land Development Code have been satisfied; and

WHEREAS, pursuant to Section 5.8, **Status** Report SR 84-121.2 was presented to the Board of County Commissioners of Palm Beach County at a public hearing conducted on July 29, 1993; and

WHEREAS, the Board of County Commissioners has reviewed Status Report SR 84-121.2 and considered testimony presented by the applicant and other interested parties, and the recommendations of the various county review agencies; and

WHEREAS, Section 5.8 of the Palm Beach County Land Development Code authorizes the Board of County Commissioners to revoke Special Exceptions; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations;
2. The revocation will eliminate an inconsistency with the Palm Beach County Comprehensive Plan; and
3. The property owner requested the revokation.

WHEREAS, Section 5.3 of the Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the recommendation of Status Report No. SR 84-121.2, to revoke the Special Exception previously granted by the approval of the petition of Thomas Datorre, Petition No. 84-121, confirmed by the adoption of Resolution R-85-257, which allowed a Planned Residential Development, on the South 1/2 of the Southwest 1/4 of the Northwest 1/4 of the Northeast 1/4 of Section 1, Township 45 South, Range 42 East, being located on the east side of Military Trail, approximately 0.8 of a mile north of Hypoluxo Road, in the

RM-Multiple Family Residential District (Medium Density) Zoning District, is approved.

Commissioner Newel moved for approval of the Resolution.
