RESOLUTION CORRECTING RESOLUTION R-99-017  
\*RESOLUTION APPROVING ZONING PETITION OF  
BOCA RATON JEWISH COMMUNITY DAY SCHOOL AND SPBCJR  
PETITION DOA84-139(G)

WHEREAS, Boca Raton Jewish Community Day School and SPBCJR, petitioned the Palm Beach County Board of County Commissioners on January 7, 1999 for Development Order Amendment (DOA) to modify/delete conditions of approval of Resolution R-96-1953; add 2 JARC unit; and add building square footage; and

WHEREAS, Resolution R-99-017, adopted on January 7, 1999 confirming the action of the Board of County Commissioners inadvertently contained errors in Conditions P.1.c and P.2.a of Exhibit C; and

WHEREAS, Conditions P.1.c and P.2.a of Exhibit C of Resolution R-99-017 should have read as follows:

- P.1. Pod A shall be limited to:
  - a. A 105 bed congregate living facility.
  - b. Twenty (20) multifamily units. (JARC housing) (BLDG/ZONING)
  - c. ~~21,290~~ 21,454 square feet and 97 (32 on site 65 outside) JARC students for assembly/resource institutional center. (BLDG/ZONING)
- P.2. Pod B shall be limited to a maximum of:
  - a. 220,000 square feet and ~~4,338~~ 1,328 students for the elementary, middle and high schools.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. Conditions P.1.c and P.2.a of Exhibit C of Resolution R-99-017 are hereby corrected.

Commissioner Marcus moved for the approval of the Resolution.
