RESOLUTION APPROVING ZONING APPLICATION ZV/Z-2008-01518 (CONTROL NO. 2006-00095) OFFICIAL ZONING MAP AMENDMENT (REZONING) WITH A CONDITIONAL OVERLAY ZONE (COZ) APPLICATION OF Cordell Shaw BY Moyle, Flanigan, AGENT (Palmwood Shaw Rezoning)

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapter 163 and Chapter 125. Florida Statutes, is authorized and empowered to consider applications relating to zoning; and

WHEREAS, the notice and hearing requirements, as provided for in Article 2 (Development Review Process) of the Palm Beach County Unified Land Development Code (Ordinance 2003-067, as amended) have been satisfied; and

WHEREAS, Zoning Application ZV/Z-2008-01518 was presented to the Board of County Commissioners at a public hearing conducted on February 25, 2009; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties, the recommendations of the various county review agencies, and the recommendation of the Zoning Commission; and

WHEREAS, this approval is subject to Article 2.E (Monitoring) of the Palm Beach County Unified Land Development Code (ULDC) and other provisions requiring that development commence in a timely manner; and

WHEREAS, the Board of County Commissioners has considered the findings in the staff report and the following findings of fact:

- 1. This official zoning map amendment (rezoning) is consistent with the Palm Beach County Comprehensive Plan;
- 2. This official zoning map amendment (rezoning) is consistent with the stated purpose, intent and requirements of the Palm Beach County Unified Land Development Code. The rezoning request is also consistent with the requirements of all other applicable local land development regulations;
- 3. This official zoning map amendment (rezoning) is compatible and generally consistent with existing uses and zones surrounding the subject land, and is the appropriate zoning district for the land;
- The applicant has demonstrated that there are sufficient changed conditions 4. or circumstances that require an amendment;
- 5. This official zoning map amendment (rezoning) does not result in significantly adverse impacts on the natural environment, including but not limited to water, air, stormwater management, wildlife, vegetation, wetlands, and the natural functioning of the environment;
- This official zoning map amendment (rezoning) will result in a logical, orderly 6. and timely development pattern; and,
- 7. This official zoning map amendment is consistent with applicable Neighborhood Plans.

8. This official zoning map amendment (rezoning) complies with Article 2.F (CONCURRENCY - Adequate Public Facility Standards) of the Palm Beach County Unified Land Development Code.

WHEREAS, Article 2.A.1.K.3.b (Action by BCC) of the Palm Beach County Unified Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Zoning Application ZV/Z-2008-01518 the application of Cordell Shaw by Moyle, Flanigan, agent, for an Official Zoning Map Amendment from the Agricultural Residential (AR) Zoning District to the Residential Transitional (RT) Zoning District with a CONDITIONAL OVERLAY ZONE on a parcel of land legally described in EXHIBIT A, attached hereto and made a part hereof, and generally located as indicated on a vicinity sketch attached as EXHIBIT B, attached hereto and made a part hereof, was approved on February 25, 2009, subject to the conditions of the CONDITIONAL OVERLAY ZONE described in EXHIBIT C, attached hereto and made a part hereof.

LEGAL DESCRIPTION

Commencing at the Northwest corner of Section 20, Township 41 South, Range 43 East, Palm Beach County, Florida; thence South 87°53'27" East along the North line of Section 20 a distance of 954.13 feet to a point in the Westerly right-of-way line of the Intracoastal Waterway; thence South 7° 58'40" East along the said right-of-way line a distance of 51.08 feet to a point; thence South 11°58'25" West along said right-of-way line a distance of 708.94 feet to a point; thence South 22°21'37" East along said right-of-way line a distance of 1039.99 feet to the Point of Beginning:

Thence North 87°53'27" West 247.62 feet to a point in the Easterly right-of-way line of Palmwood Road; thence Southeasterly and Southerly along said right-of-way line on the arc of a curve concave Southwesterly having a radius of 2904.93 feet through a central angle of 2°09'17" a distance of 109.24 feet to a point; thence South 87°43'14" East 266.06 feet to the intersection of the Westerly right-of-way line of the Intracoastal Waterway and the East line of the West Half of the Northwest Quarter of Section 20, Township 41 South, Range 43 East; thence North 22°21'37" West along said right-of-way line a distance of 116.34 feet to the Point of Beginning.

Otherwise described as Lot 13 of Palmwood Estates, Unrecorded Plat.

VICINITY SKETCH



CONDITIONS OF APPROVAL

ENGINEERING

1.On or before July 29, 2009, the property owner shall provide by warranty deed submitted to Palm Beach County Land Development Division for 70 feet of right of way from centerline of Palmwood Road, to provide for 110 feet ultimate right of way. Right of way conveyance shall be along the project's entire frontage and shall be free and clear of all encumbrances and encroachments. Property owner shall provide Palm Beach County with sufficient documentation acceptable to the Right of Way Acquisition Section to ensure that the property is free of all encumbrances and encroachments. Thoroughfare Plan Road right of way conveyances shall be consistent with Palm Beach County's Thoroughfare Right of Way Identification Map and shall include where appropriate as determined by the County Engineer additional right of way for corner clips. (BLDG PERMIT: MONITORING-Eng)

COMPLIANCE

- 1. In granting this approval, the Board of County Commissioners relied upon the oral and written representations of the petitioner both on the record and as part of the application process. Deviations from or violation of these representations shall cause the approval to be presented to the Board of County Commissioners for review under the compliance condition of this approval. (ONGOING: MONITORING Zoning)
- 2. Failure to comply with any of the conditions of approval for the subject property at any time may result in:
- a. The issuance of a stop work order; the issuance of a cease and desist order; the denial or revocation of a building permit; the denial or revocation of a Certificate of Occupancy; the denial of any other permit, license or approval to any developer, owner, lessee, or user of the subject property; the revocation of any other permit, license or approval from any developer, owner, lessee, or user of the subject property; revocation of any concurrency; and/or
- b. The revocation of the Official Map Amendment, Conditional Use, Requested Use, Development Order Amendment, and/or any other zoning approval; and/or
- c. A requirement of the development to conform with the standards of the ULDC at the time of the finding of non-compliance, or the addition or modification of conditions reasonably related to the failure to comply with existing conditions; and/or
- d. Referral to code enforcement; and/or
- e. Imposition of entitlement density or intensity.

Staff may be directed by the Executive Director of PZ&B or the Code Enforcement Special Master to schedule a Status Report before the body which approved the Conditional Use, Type II Variance, Development Order Amendment, and/or other zoning approval, in accordance with the provisions of Section 2.E of the ULDC, in response to any flagrant violation and/or continued violation of any condition of approval.

Departmental administrative actions made pursuant to this condition may be appealed as provided in the Unified Land Development Code (ULDC), as amended. Appeals of any revocation of a Conditional Use, Type II Variance, Development Order Amendment or other actions based on a Zoning Commission decision shall be by petition for writ of certiorari to the Circuit Court, Appellate Division, 15th Judicial Circuit of Florida.
