RESOLUTION APPROVING ZONING APPLICATION ZV/DOA/W-2022-01515 (CONTROL NO. 2008-00259) a Development Order Amendment APPLICATION OF Dack Beeline LLC BY WGINC, AGENT (Debris Dog)

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider applications relating to zoning;

WHEREAS, the notice and public hearing requirements pursuant to Article 2 (Application Processes and Procedures) of the Palm Beach County Unified Land Development Code, Ordinance 2003-067 as amended (ULDC), have been satisfied;

WHEREAS, Zoning Application ZV/DOA/W-2022-01515 submitted on behalf of Dack Beeline LLC by WGINC, Agent for a Development Order Amendment to reconfigure the site plan, to expand the use; and modify Conditions of Approval on 10.00 acres; and for a Type 2 Waiver to allow an alternative Type 3 Incompatibility Buffer to substitute a six foot wall with a six foot hedge and fence along the south; and a six foot hedge east, north and west property lines on 10.00 acres was presented to the Board of County Commissioners at a public hearing conducted on June 22, 2023;

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the Applicant and other interested parties, the recommendations of the various County Review Agencies, and the recommendation of the Zoning Commission;

WHEREAS, the Board of County Commissioners pursuant to Article 2 (Application Processes and Procedures) of the ULDC is authorized and empowered to consider, approve, approve with conditions or deny the request;

WHEREAS, the Board of County Commissioners hereby incorporates by reference the Findings in the staff report addressing the Standards contained in Article 2.B (Public Hearing Processes) for a Development Order Amendment;

WHEREAS, this approval is subject to Article 2.E (Monitoring), of the ULDC and other provisions requiring that development commence in a timely manner;

WHEREAS, the issuance of this Development Permit does not in any way create any rights on the part of the Applicant and/or Property Owner to obtain a permit from a state or federal agency and does not create any liability on the part of the County for issuance of the permit if the Applicant fails to obtain requisite approvals or fulfill the obligations imposed by a state or federal agency or undertakes actions that result in a violation of state or federal law;

WHEREAS, the Palm Beach County Survey Section may administratively correct any scrivener's errors that will not significantly impact the overall boundary of the adopted legal description; and,

WHEREAS, Article 2.B.6.C (Board Action) of the ULDC requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Zoning Application ZV/DOA/W-2022-01515, the Application of Dack Beeline LLC, by WGINC, Agent, for a Development Order Amendment to reconfigure the site plan, to expand the use; and modify Conditions of Approval on 10.00 acres, on a parcel of land generally described as shown on the legal description in EXHIBIT A, attached hereto and made a part hereof, and

generally located as shown on a vicinity sketch as indicated in EXHIBIT B, attached hereto and made a part hereof, was approved on June 22, 2023, subject to the Conditions of Approval described in EXHIBIT C, attached hereto and made a part hereof.

VICINITY SKETCH



CONDITIONS OF APPROVAL

Development Order Amendment

ALL PETITIONS

1. Previous ALL PETITIONS Condition 1 of Resolution R-2019-002, Control No.2008-00259, which currently states:

Development of the site is limited to the uses and site design approved by the Board of County Commissioners. The approved Preliminary Site Plan is dated August 27, 2018. Modifications to the Development Order inconsistent with the Conditions of Approval, or changes to the uses or site design beyond the authority of the Development Review Officer as established in the Unified Land Development Code, must be approved by the Board of County Commissioners.

Is hereby amended to read:

Development of the site is limited to the uses and site design approved by the Board of County Commissioners. The approved Preliminary Site Plan is dated May19, 2023. Modifications to the Development Order inconsistent with the Conditions of Approval, or changes to the uses or site design beyond the authority of the Development Review Officer as established in the Unified Land Development Code, must be approved by the Board of County Commissioners. (ONGOING: ZONING - Zoning)

2. All previous Conditions of Approval applicable to the subject property, as contained in Resolution R-2019-002 (Control 2008-0259), have been consolidated as contained herein. The Property Owner shall comply with all previous Conditions of Approval and deadlines previously established by Article 2.E of the Unified Land Development Code and the Board of County Commissioners, unless expressly modified. (ONGOING: ZONING - Zoning)

ENGINEERING

1. In order to comply with the mandatory Traffic Performance Standards, the Property Owner shall be restricted to the following phasing schedule:

a. No Building Permits for the site may be issued after December 31, 2021. A time extension for this condition may be approved by the County Engineer based upon an approved Traffic Study which complies with Mandatory Traffic Performance Standards in place at the time of the request. This extension request shall be made pursuant to the requirements of Art. 2.E of the Unified Land Development Code. (DATE: MONITORING - Engineering) [Note: COMPLETED] (Previous ENGINEERING Condition 1 of Resolution R-2019-2, Control No.2008-00259)

2. The Property Owner shall provide to the Florida Department of Transportation (FDOT), a road right of way deed and all associated documents as required by FDOT for Beeline Highway forty (40) width on an alignment approved by the FDOT or County Engineer

All right of way deed(s) and associated documents shall be provided and approved prior to the issuance of the first building permit. Right of way conveyance shall be along the project's entire frontage and shall be free and clear of all encumbrances and encroachments. Property Owner shall provide FDOT with sufficient documentation, including, at a minimum, sketch and legal description of the area to be conveyed, copy of the site plan, a Phase I Environmental Site Assessment, status of property taxes, statement from Tax Collector of delinquent and pro-rata daily taxes, full owner name(s) of area to be conveyed, and one of the following: title report, attorney's opinion of title, title commitment or title insurance policy, or as otherwise required and acceptable to FDOT. The Property Owner must warrant that the property being conveyed to FDOT meets all appropriate and applicable environmental agency requirements. In the event of a determination of contamination which requires remediation or clean up on the property now owned by the Property Owner, the Property Owner agrees to hold the County and FDOT

harmless and shall be responsible for all costs of such clean up, including but not limited to, all applicable permit fees, engineering or other expert witness fees including attorney's fees as well as the actual cost of the clean up. Thoroughfare Plan Road right of way conveyances shall be consistent with Palm Beach County's Thoroughfare Right of Way Identification Map and shall include where appropriate, as determined by the County Engineer, additional right of way for Expanded Intersections and Corner Clips. The Property Owner shall coordinate conveyance of right of way directly with FDOT and shall provide evidence to Palm Beach County Land Development Division once conveyance has been completed. (BLDGPMT: MONITORING - Engineering) [Note: COMPLETED] (Previous ENGINEERING Condition 2 of Resolution R-2019-2, Control No.2008-00259)

ENVIRONMENTAL

1. Previous ENVIRONMENTAL Condition 1 of Resolution R-2019-2, Control No.2008-00259, which currently states:

An exotic seed management plan shall be approved by the Department of Environmental Resources Management (ERM) prior to the approval of the site plan by the Development Review Officer (DRO).

Is hereby amended to read:

Prior to final approval by the Development Review Office (DRO) the Applicant shall provide a revised Exotic Seed Management Plan to the Department of Environmental Resources Management (ERM) for review and approval. (DRO: ENVIRONMENTAL RESOURCES MANAGEMENT - Environmental Resources Management)

2. Prior to the final approval by the DRO, the Applicant shall provide a copy of a formal wetland jurisdictional determination from the Department of Environmental Protection, South Florida Water Management District and/or the Army Corps of Engineers. (DRO: ENVIRONMENTAL RESOURCES MANAGEMENT - Environmental Resources Management)

3. Prior to the final approval, the Applicant shall provide documentation to confirm that the mesh screen material was re-installed. (DRO/ONGOING: ENVIRONMENTAL RESOURCES MANAGEMENT - Environmental Resources Management)

4. Prior to the final approval by the DRO, the Applicant shall provide a dust abatement plan to ERM for review and approval. (DRO: ENVIRONMENTAL RESOURCES MANAGEMENT - Environmental Resources Management)

HEALTH

1. Prior to the issuance of the first building permit, the property owner shall apply for and obtain construction permits for a potable water supply well and an onsite sewage treatment and disposal system (OSTDS). (BLDGPMT: HEALTH DEPARTMENT - Health Department) [Note: COMPLETED] (Previous HEALTH Condition 1 of Resolution R-2019-2, Control No.2008-00259)

LANDSCAPE - GENERAL

1. Previous LANDSCAPE - GENERAL Condition 1 of Resolution R-2019-2, Control No.2008-00259, which currently states:

Prior to the issuance of the first building permit, the Property Owner shall finalize the Preliminary Vegetation Disposition Chart to ensure all Vegetation that is subject to either preservation; relocation on site; replacement or mitigation shall be clearly identified on the Site Plan. The Chart and what is shown on the Plan shall be consistent.

Is hereby amended to read:

Prior to final Development Review Officer (DRO), the Property Owner shall revise the Preliminary Vegetation Disposition Chart to ensure all Vegetation that is subject to either preservation; relocation on site; replacement or mitigation shall be clearly identified on the

Site Plan. The Chart and what is shown on the Plan shall be consistent. (BLDGPMT: ZONING - Zoning)

2. Prior to Final Approval by the Development Review Officer, the Site Plan shall be amended to provide a minimum eight-foot wide landscape buffer along the perimeter of the parking lot and access way for the administrative building, to include a six-foot high vinyl coated chain link fence and hedge. (DRO: ZONING - Zoning) (Previous LANDSCAPE - GENERAL Condition 2 of Resolution R-2019-2, Control No.2008-00259)

SITE DESIGN

1. Previous SITE DESIGN Condition 1 of Resolution R-2019-2, Control No.2008-00259, which currently states:

Prior to Final Approval by the Development Review Officer (DRO), the Property Owner shall amend the Site Plan to correctly identify the developable portion of the site, including removing references to limits of cleared area; and, delineating the boundary of all outdoor activity areas, to include a minimum 20 foot setback from the administrative building and required parking and access ways. (DRO/ONGOING: ZONING - Zoning)

Is hereby deleted. [REASON: The entire site is being developed.]

USE LIMITATIONS

1. The onsite equipment storage areas, as noted on the Preliminary Site Plan dated May 19, 2023, shall be limited to on-site equipment only. No rental trucks or tractor trailers shall be permitted to be stored on site. (ONGOING: ZONING - Zoning)

2. The use and operation of site shall be limited to Yard Trash, Vegetative Land Clearing Debris, and Clean Wood Recycling and Composting Facility pursuant to SWA permit DD 0081 YT21. (ONGOING: ZONING – Zoning)

3. Bio-solids, food waste, equestrian waste, animal waste or construction debris on the site is prohibited. (ONGOING: ZONING – Zoning)

COMPLIANCE

1. In Granting this Approval, the Board of County Commissioners relied upon the oral and written representations of the Property Owner/Applicant both on the record and as part of the application process. Deviations from or violation of these representations shall cause the Approval to be presented to the Board of County Commissioners for review under the Compliance Condition of this Approval. (ONGOING: ZONING - Zoning)

2. Failure to comply with any of the Conditions of Approval for the subject property at any time may result in:

a. The Issuance of a Stop Work Order; the Issuance of a Cease and Desist Order; the Denial or Revocation of a Building Permit; the Denial or Revocation of a Certificate of Occupancy; the Denial of any other Permit, License or Approval to any developer, owner, lessee, or user of the subject property; the Revocation of any other permit, license or approval from any developer, owner, lessee, or user of the subject property; the Revocation of any other permit, license or approval from any developer, owner, lessee, or user of the subject property; the Revocation of any concurrency; and/or

b. The Revocation of the Official Map Amendment, Conditional Use, Requested Use, Development Order Amendment, and/or any other zoning approval; and/or

c. A requirement of the development to conform with the standards of the Unified Land Development Code at the time of the finding of non-compliance, or the addition or modification of conditions reasonably related to the failure to comply with existing Conditions of Approval; and/or

d. Referral to Code Enforcement; and/or

e. Imposition of entitlement density or intensity.

Staff may be directed by the Executive Director of PZ&B or the Code Enforcement Special Master to schedule a Status Report before the body which approved the Official Zoning Map Amendment, Conditional Use, Requested Use, Development Order Amendment, and/or other zoning approval, in accordance with the provisions of Section 2.E of the

ULDC, in response to any flagrant violation and/or continued violation of any Condition of Approval. (ONGOING: ZONING - Zoning)

1. All applicable state or federal permits shall be obtained before commencement of the development authorized by this Development Permit.
