#### **Description:**

Multiculturalism, largely resulting from diversification and immigration, is a marked characteristic of the United States. After completing her school psychology internship with Miami-Dade County Public Schools and working as a school psychologist in various counties throughout the state of Florida, Dr. Cruz completed her doctorate in combined counseling and school psychology, with a specialization in child clinical psychology at Florida State University (Tallahassee, Florida). She completed her doctoral internship at Jackson Behavioral Health Hospital (Miami, Florida) in the crisis stabilization unit and Statewide Inpatient Psychiatric Program (SIPP) for children and adolescents. Later, Dr. Cruz went on to complete a postdoctoral fellowship at the University of Miami, Mailman Center for Child Development, specializing in Parent-Child Interaction Therapy (PCIT). At the Youth Services Department of Palm Beach County, Dr. Cruz serves as a licensed psychologist providing education and training to staff/community, clinical supervision to trainees, and clinical services to youth and families in both English and Spanish. Dr. Cruz also serves as adjunct faculty at Nova Southeastern University in their School Psychology specialist and doctoral programs. She has completed training and certification in PCIT and has expertise in the areas of behavioral parent training, treatment of disruptive behaviors, neurodevelopmental disabilities, and best practices in assessment.
