# Fiberglass Manufacturer to Open New Plant in Palm Beach County

Fibex, LLC, a composite materials supplier, plans to bring its manufacturing operations to Palm Beach County.

Earlier this month, the Board of County Commissioners approved the issuance of \$3 million in industrial development revenue bonds in connection with the acquisition, renovation and equipping of an existing building on the West 13th Street industrial corridor in Riviera Beach.

Activities at the new plant will include the manufacture of technical fiber products



for the composite material industry by converting fiberglass, carbon and other heatresistant and strong synthetic fibers, resulting in woven and knitted tapes that are used to restore, protect and reinforce pipelines and civil structures. The products are marketed to numerous industries, including aerospace, automotive, construction, defense, energy, marine, transportation, and sports and recreation. Their products are sold both domestically and internationally.

The company is also working with DES on additional financial leveraging sources for working capital. The project to expected to create at least 25 new full-time jobs within the first five years and to generate an estimated economic impact of \$16.9 million.

## **County Shares Economic Development Strategies at National Conference**

DES Deputy Director Sherry Howard shared examples of Palm Beach County-assisted business expansion projects in a presentation at the annual conference of the National Forum of Black Public Administrators (NFBPA), held in Tampa in April. The presentation included a panel discussion of non-

traditional financing for projects and how local governments can market those resources.

The conference drew attendees from around the country and offered a variety of workshops and sessions on leadership, public policy, and community and economic development.

## **CDBG Projects Featured at National Planning Conference**

At it's annual conference this month in Seattle, the American Planning Association featured several economic development, affordable housing, and infrastructure projects completed by Palm Beach County using Community Development Block Grant (CDBG) funds.

The projects, which include Oxygen Development in Palm Springs, McClure Village in Pahokee, and road improvements in Lake Worth, among others, will help illustrate how federal dollars can help transform communities from blight to beautiful, and encourage reinvestment by the private sector.

#### **Disaster Recovery Dollars Fix Hurricane Damage**

The County recently completed improvements at two affordable housing communities in West Palm Beach, thanks to the State's Disaster Recovery Initiative, a program created to help areas repair damage caused by hurricanes.

Housing units at Newton Woods were assisted with nearly \$1 million to provide new exterior stucco surfacing and paint, hurricane strapping of all framing, and impact-resistant windows and doors. At the Southridge Apartments for seniors, more than \$450,000 funded repairs which included improved stormwater drainage, new parking lot surfacing, striping and signage, and new sidewalks and ramps.

## **Partnership with Lake Worth Creates Greenway, Road Improvements**

Palm Beach County, through an investment of more than \$300,000 of CDBG funds helped the City of Lake Worth complete new road improvements at South E Street and 9th Avenue South and 10th Avenue South. Features now include a new greenway, sidewalks with ADA ramps, curb and gutter, pavement, landscaping, irrigation, signage, trash receptacles and benches, greatly enhancing the area for pedestrian traffic.







DES utilizes the nationally recognized Regional Economic Models, Inc. (REMI) program to conduct accurate and timely studies to determine a project's potential economic impact on a community. Since FY 2012, economic impact analyses performed on DES-administered projects indicate a five-year economic impact of \$16.4 Billion, and the creation of more than 49,000 direct and indirect jobs.
