Appendix B - Citizen Participation Plan

Encouragement of Citizen Participation

In accordance with 24 CFR Part 91, et al., Palm Beach County's Citizen Participation Plan provides for citizens to participate in the development of the consolidated plan, the annual action plan, any substantial amendments to the Consolidated Plan and the Action Plan, and performance reports. Citizen participation is solicited via one or a combination of the following: public meetings (in-person or virtual), newspaper advertisements, website postings, social media, surveys, and direct notifications. Low- and moderate-income persons, particularly those living in predominantly low- and moderate income areas, slum and blighted areas and in areas where CDBG funds are proposed to be used, are particularly targeted. Palm Beach County also encourages the participation of all its citizens, including minorities and non-English speaking persons, as well as persons with disabilities. During the development and implementation of the Consolidated Plan, the participation of municipalities forming the Urban County, local and regional institutions and other organizations (including businesses, developers, and community and faith-based organizations) is also encouraged.

Palm Beach County will provide bilingual translators for public meetings where a significant number of non-English speaking residents are expected to participate, when requested with three (3) days advance notice. The County complies with Americans with Disabilities Act (ADA) requirements as it relates to public meetings and related activities. All printed documentation incorporates a statement with instructions for requesting the documentation in alternate format. Public notices advise of the availability of special arrangements for persons with disabilities when requested with three (3) day advance notice.

Through collaboration with the public housing agencies within its jurisdiction, Palm Beach County encourages the participation of residents of public housing developments, along with other low-income residents of targeted revitalization areas in which the developments are located. The County makes efforts to provide information to the public housing agency about consolidated plan activities so that the public housing agency can make this information available to its residents.

As required by the Citizen Participation regulations, Palm Beach County has prepared a Plan to minimize displacement of persons and to assist any persons displaced through the implementation of any activity funded under the Consolidated Plan. The County's Residential Anti-displacement and Relocation Assistance Plan is included in the Five Year Consolidated Plan as a separate document. This Plan specifies the types and levels of assistance the County will make available (or require others to make available) to persons displaced, and states when and how the jurisdiction will make this information available.

Citizen Comments on the Citizen Participation Plan and Amendments

The Citizen Participation Plan is disseminated to the public through posting on the Department of Housing and Economic Sustainability (DHES) website, publication in a newspaper of general circulation, and inclusion within the Consolidated Plan. Citizens are provided with reasonable opportunity to comment on the Plan and amendments thereto. The County's Citizen Participation Plan is prepared every five years simultaneously with the Consolidated Plan. The Citizen Participation Plan becomes an Appendix of the

Consolidated Plan, and as such, the Citizen Participation Plan is subject to the same public exposure and scrutiny as the Consolidated Plan.

Development of the Consolidated Plan

The following requirements are adopted under this Citizen Participation Plan to guide the development of the Consolidated Plan and the annual Action Plan:

- a) Various stakeholders and known interested parties will be contacted to provide information needed to undertake the needs assessment and to formulate goals and objectives to be addressed in the Consolidated Plan.
- b) No less than two (2) public meetings will be held to advise citizens of the planning process and to solicit input. Notice of this public meeting will be published in a newspaper of general circulation, posted on DHES's website at least 7 days before the meeting date, and sent directly to known interested parties.
- c) Drafts of the Consolidated Plan and Action Plan will be made available for public review and comments before adoption. The draft plans include, among other things, the amount of funding the County expects to have available to meet the community needs identified, the range of activities that it will be undertaken (including their location), the estimated number of persons to benefit from the activity and the percentage of these who are low- and moderate-income.
- d) The draft Plans will be made available in a manner that affords all interested parties a reasonable opportunity to examine its contents and to submit comments. The County will publish a notice of the Plan's availability in a newspaper of general circulation, and on the DHES website. Citizens will be allowed no less than 30 days to provide comments. Comments not provided at a public meetings must be written.
- e) The County will consider any comments or views of citizens received when preparing the Consolidated Plan. A summary of these comments or views, and a summary of any comments or views not accepted and the reasons therefore, will be attached to the final Consolidated Plan.
- f) The Palm Beach County Board of County Commissioners will adopt the Consolidated Plan and Action Plan at a public meeting. Public notice of the meeting(s) will be posted at least 15 days in advance in a newspaper of general circulation and on the DHES website. Public comments emanating from the meeting will be summarized and included in the Plan.

Amendments

Palm Beach County distinguishes between two (2) types of amendments to the Consolidated Plan and Action Plan – Substantial Amendments and Minor Amendments. A Substantial Amendment is required when a new activity or goal/priority is being added, and when an existing activity or goal/priority is being deleted. All other changes are considered to be Minor amendments, including but not limited to:

- Activity funding is increased or decreased
- The scope of the activity is changed
- The location of the activity is changed
- The beneficiaries of the activity are changed

• The implementing entity for the activity is changed

Amendment Approval Process

Amendments do not require approval by the Board of County Commissioners (BCC), however, the Department Director may decide to present a proposed change to the BCC for approval before an amendment is processed for approval. The amendment approval process is as follows:

- All Substantial Amendments are advertised in a local newspaper of general circulation and on the DHES website, then followed by a fifteen (15) day comment period.
- All Minor Amendments are advertised in a local newspaper of general circulation and on the DHES website, then followed by a seven (7) day comment period.
- Any comments received are taken into consideration, summarized, and maintained in the amendment file.
- An Amendment Approval Form (see Appendix ___, Attachment 1) is circulated for review and signatures within DHES.
- Upon expiration of the comment period, the Department Director signs to provide final approval.
- Copies of the fully executed Amendment Approval Form are distributed to all signatories.
- All amendments are recorded on the running list of amendments.

Public Notices and Public Comments

The Citizen Participation Plan provides citizens with reasonable notice and an opportunity to comment on Substantial and Regular amendments. A public notice of the proposed amendment will be published in a newspaper of general circulation, and posted on the DHES website. The notice will describe the proposed amendment including activity description, location, beneficiaries, funding, and nature of the amendment. The notice will include the date/time/location of public meetings regarding the proposed amendment, if any. Substantial Amendments provide for a fifteen (15) day comment period and Minor Amendments provide for at least seven (7) day comment period before the amendment is approved.

Palm Beach County will consider any public comments or views received in writing, or orally at public meetings. A summary of these comments or views, and a summary of any comments or views not accepted and the reasons therefore, will be attached to the amendment.

Environmental Assessments

The Citizen Participation Plan provides citizens with reasonable notice and an opportunity to comment on Environmental Assessments, when required by 24 CFR 58.36. A Finding of No Significant Impact (FONSI) is published in a newspaper of general circulation and posted on the DHES website. Concurrently, a Notice of Intent to Request the Release of Funds (NOIRROF) from HUD is published with the FONSI. Citizens are allowed fifteen (15) days to submit written comments prior to submission of the FONSI/ NOIRROF to HUD.

Performance Reports

Palm Beach County Citizen Participation Plan provides citizens with reasonable notice and an opportunity to comment on performance reports. Prior to submitting the Consolidated Annual Performance and Evaluation Report (CAPER), Palm Beach County publishes a public notice in a newspaper of general circulation and on the DHES website advertising the availability of the draft CAPER for review. Citizens

are allowed fifteen (15) days to submit written comments. The Draft CAPER is posted on the website and also made available for review at the DHES office. Palm Beach County considers any written comments received. A summary of these comments is attached to the CAPER.

Public Meetings

Palm Beach County Citizen Participation Plan will provide for at least three (3) public meetings per year to obtain citizens' views and to respond to questions regarding the Consolidated Plan. The meetings may be held in-person or virtually using ZOOM, WEBEX or an available public access application. The meetings must be conducted at 3 different stages of the program years and will address housing and community development need, development of proposed activities, and review of program performance.

Palm Beach County will hold at least two (2) public meetings at the commencement of the preparation of the Consolidated Plan and the Action Plan and will hold two (2) or more public meetings during development of the Plans, including at least one (1) to discuss the draft Plans. Finally, approval of the Plans by the Board of County Commissioners will be done at a public meeting. The purpose of the meetings is to describe the consolidated planning process, explain the HUD-funded programs including but not limited to the range of eligible activities and levels of funding available, obtain citizen views on housing and community developments needs including non-housing priority community development needs, and provide information on past performance. Notice of all meetings will be published in the newspaper of general circulation and on the DHES website at least seven (7) days in advance. The notice will include all the proposed meeting dates, times and locations and will advise of special accommodations for non-English speakers or persons with disabilities. A summary of the proposed Consolidated Plan and Action Plan will be published concurrent with notices of meetings to approve the Plans.

Availability to the Public

The Draft Consolidated Plan, the Final Consolidated Plan, the Citizen Participation Plan, the Assessment of Fair Housing, the CAPER and other Performance Reports will be made available to the public via public notices and via DHES's website. All printed documents incorporate a statement which serves to inform interested participants that it can be made available in alternate format. Additionally, each public notice includes language which informs the reader of the availability of special arrangements for persons with disabilities. These provisions will be made available with a three (3) working day notice in advance, on the part of the participant in need.

Access to Records

Florida Statute Chapter 119 ("Public Records Law") provides for broad access to public records. All public records related to Palm Beach County's Consolidated Plan and uses of funds under the programs covered by the Consolidated Plan during the preceding five years will be made available to persons requesting such records. Copies of records will be provided in accordance with DHES Policy and Procedure Memorandum EC-R-004. Files will be made available for inspection during normal business hours at DHES Offices, 100 Australian Avenue, Suite 500, West Palm Beach, FL 33406. Records related to the Consolidated Plan will be maintained for not less than five years following adoption of the Consolidated Plan. Minutes from meetings or audio recordings of meetings are available for review at DHES. Persons requesting public records should contact DHES at (561) 233-3600.

Technical Assistance

DHES will provide technical assistance to outside persons and entities in regards to all programs and activities covered by the Consolidated Plan. The level and type of assistance is determined by the County. DHES staff will meet with elected officials, municipal staff, private organizations, and members of the general public requesting such assistance.

Palm Beach County offers following types of technical assistance:

- Assistance to citizens, established citizen committees, and organizations in order to provide them with adequate tools for participation in the development, planning, implementing and assessment of programs/activities.
- Assistance to groups that request assistance in developing proposals for funding assistance. Assistance will focus on the interpretation of applicable regulations and instruction in the preparation of proposals/applications. The provision of assistance does not guarantee the provision of funds to the groups.
- Assistance to citizens in organizing and operating neighborhood and project area organizations (i.e. CHDOs) in an effort to engage in CPD program related activities.

Technical Assistance is available year-round. All scheduled public meetings allow for question and answer sessions related to community development related concerns.

Comments and Complaints

All comments received in writing or orally at public meetings in preparation of the Consolidated Plan, the Action Plan, amendments to the Plans, and performance reports, will be summarized and attached to each document, respectively, and will include a summary of any comments not accepted and the reasons therefore.

If the response received is found to be unsatisfactory, the complainant(s) may elect to extend their complaints to the Assistant County Administrator. If again, the complainant(s) are not satisfied with the decision made by the Assistant County Administrator, matters may be brought to the attention of the County Administrator and the Board of County Commissioners of Palm Beach County.

HUD provides these numbers to us and these are the figures that we have to work with.

Commissioner McKinley

Stated that the fair market rent for a 2 BR unit in the Glades area of Palm Beach County is less than the rent for the County as a whole. Stated that it is hard to get builders into the Glades to build housing due to lack of rental funding.

Also wondered if there was an opportunity to increase funding to agencies that assist victims of domestic abuse.




Q3 Do you consider your housing to be affordable?



Q4 How much of your income do you spend on housing costs?





Q9 Are you currently homeless?







Q12 Do you see a need for additional social service programs in your community?







Stone leaves trial early claiming food poisoning

WASHINGTON — The trial of Roger Stone, the flamboyant former confi-dant of President Donald Trump, kicked off Tuesday amid a host of medical issues involving both the defendant and a spectator. Shortly after Jury selection began, the courtroom had to be cleared for more than a half hour when a mansitting in the back row mounted loudly and collapsed on the floor. He was revived and helped from the room by medical staff. Not long after the session resumed, Stone himself went home early, telling U.S. District Judge Amy Berman Jackson that he had food poisoning.

Stone, a long time Republican provocateur, faces charges related to allegations he sought to collaborate with Wildicaks to release eranils hacked by Russia to damage Hillary Clinton's Democratic presidential campaign.

The trial in Washington promises to revive the special counsel Robert Mueller's investigation as the impeachment inquiry agains Trump proceeds in the House.

lying to lawmakers about Wikileaks, tampering with witnesses and obstructing a House Intelligence Committee probe into whether the Trump campaign coordinated with Russia to tip the 2016 election. Stone, whose history in Republican political circles dates back to the Nixon administration, has consistently criticized the Nixon administration, has consistently criticized the case against him as politically motivated. Day One was focused on jury selection and featured Some of the political complexities that may dominate the case. Jackson started the day by fending off attempts by the defense team to exclude any potential jurors who worked in the U.S. government or had a negative view of Trump. Berman pointed out that excluding all government workers may be impossible given the nature of the District of Columbia jury pool.

Sure enough, the first potential juror was a woman who had worked in the Office of Management and Budget in the Office of Management and Budget in the Office of Management on the Office of Management of Justice.

Jackson also rejected the notion that a juror who was opposed to Trump would not be fair to Stone.

Stone, a longtime friend of the president's, briefly served on Trump's campaign but was pushed out amid infighting with campaign manager Corey Lewandowski. Though sidelined, he continued to communicate with Trump and stayed plugged into his circle of advisers.

The indict ment says Stone, who was arrested by the TBI in a raid at his Florida home, repeatedly discussed WikiLeaks in 2016 with campaign associates and lays out in detail Stone's conversations about emails stolen from Clinton campaign chairman John Podest and posted in the weeks before Trump beat Clinton.

After WikiLeaks released hacked emails from the Democratic National Committee on July 22, 2016, the indictment says, a senior Trump campaign official "was directed" to contact Stone about what other damaging information "WikiLeaks had "regarding the Clinton campaign."

The indictment does not ame the official or say who directed the outreach to Stone.

Trump International Hotel & Tower Chicago, which prides itself on indugent luxury, is trying to keep up by cutting costs. In a presentation to investors, obtained by The Post, the company described leaving jobs open, cutting back on giffs for high rollers and children, and buying chaper housekeeping supplies.
As Trump concludes the tumultuous third year of his presidency, it is becoming clear that the political environment he helped create is having consequences for the real estate empire he and his family built.
While his properties have benefited from his repeated visits and business from conservative customers, there are signs that at least parts of the company are struggling,

beset by financial set-backs, regulatory and legal battles, and a tarnished brand name. From the outside, it is not possible to gauge how serious those problems are for the company as a whole, and the Trump Organization declined to comment for this article. But, in recent days, the company has announced two other moves that seem sharply out of character.

In late October, the Trump Organization said that it was considering selling the lease on its District of Columbia hotel, one of its marquee properties. The decision came despite the company's previous reluctance to sell any Trump-branded real estate, and though the hotel opened only three years ago after a massive, \$200 million renovation. In New York, the company recently redecorated two properties - a pair of ice rinks in Central Park - to remove or reduce in size uses of the name "Trump." It was a small change with huge symbolism: A company built around Trump's world-famous name was now

Stephens clearly deserves some compensation for being "shot for no reason" and being consigned to "a lifetime imprisoned in a wheelchair with no bowel or bladder control and completeloss of sexual func-tion," Scarola said.

Suspecting Scarola might have ulterior motives for pushing the eye-popping claims bill, Levesque said the Legislature wants proof of how much Stephens has accumulated inmedicabilis. A video of the shooting, captured by Lin's dash-board camera, shows that Lin fired four shots seconds after getting out of his patrol car. When Lin confronts Stephens, he is out of view of the camera. Then, Stephens reappears, turns, tries to

Whether he raised his hands or not isn't discernible on the video. However, during the 2016 trial in U.S. District Court, Lin testified that Stephens obeyed his order to raise his obeyed his order to raise his hands, according to a court

Months after he was awarded \$2.2.5 million, Stephens was arrested in his wheelchair after sell-ing drugs to an undercover sheriff's office. Evenso, Stephens told the special master he had never sold drugs, Levesque said. Scarola and others have long insisted that Stephens was set up by the sheriff's office to keep him from getting the money the jury said he deserved.

Biden's vice-presidential search gathers steam

Joe Biden's advisers have conducted several rounds of interviews with a select group of vice-presidential candidates and are beginning to gather private documents from some of them, as they attempt to winnow a field that features the most discrete orderizes conducted. most diverse set of vice-presidential contenders in history.

The search committee

has been in touch with roughly a dozen women, and some eight or nine are already being vetted more intensively.

already being vetted more intensively.

Among that group are two contenders who have recently grown in prominence, Rep. Val Demings of Florida and Mayor Keisha Lance Bottoms of Atlanta. One well-known candidate, Sen. Amy Klobuchar of Minnesota, has lost her perch as a front-runner. And some lower-profile candidates, like Sen. Tammy Baldwin of Wisconsin, are advancing steadily in the search

process.
The New York Times spoke to an array of people who are familiar with the vice-presidential search and the activities of the Biden team, and the inter-views yielded the fullest picture yet of the list of candidates Biden is concandidates Biden is con-sidering, who is advancing and who may be fading, and the dynamics at play. Biden's vice-presiden-tial search has taken a

bifurcated course so far, with one path unfold-ing in the open — joint appearances on televiappearances on televi-sion or in virtual events

with potential running mates — and another in an environment of strict discretion. People involved in the confidential part described it on condition of anonymity, because they were not authorized to discuss a process that is designed to shield Biden's thinking and the participants' privacy.

Some of the contenders who have advanced furthest in the process are well known, including Sens. Kamala Harris, of California, and Elizabeth Warren, of Massachusetts. But the Times confirmed that several other women — whose names have been repeatedly floated but who have not publicly confirmed that they agreed to be vetted for the job — are under active consideration as well.

Harris and Warren have been interviewed at length

harris and Warren have been interviewed at length by Biden's team, as has Baldwin, who was the first openly gay candidate ever elected to the Senate.

Two women with dis-tinctive national-defense

credentials have also been interviewed and asked for documents: Sen. Tammy Duckworth, of Illinois, an Iraq War combat veteran who is Asian American, and Susan Rice, the former national security adviser to President Barack Obama and the first black woman to serve as ambassador to the United Nations.

As the vetting pro-

As the vetting process advances to a newly intense phase, the political currents of the last few weeks are also leaving a mark on the Biden team's deliberations. The wave of demonstrations touched off by the killing in Minneapolis of George Floyd, a black man, at the hands of a white police officer there, has elevated a pair of black women long regarded as intriguing long-shot candidates: Demings and Bottoms.
Though Demings and Bottoms are far less known to the national electorate than other figures on Bider's list, they

ures on Biden's list. th ures on Biden's list, they have played crucial roles in a cascading civil rights crisis: Demings, a former police chief in Orlando, Florida, has become a major figure in the lawenforcement debate, while Bottoms' handling of chaotic demonstra-tions in her city earned her national acclaim

"I want someone strong," he said, "and someone who is ready to be president on Day One."

Rep. Dina Titus, of Newada, a prominent early supporter of Siden, counseled him to not be eaught up in a momentary news cycle but rather make a sober-minded governing choice, someone to help him steer through turbulent years ahead.
"He needs to pick somebody who's serious, respected and has some policy chops," Titus said, "not just somebody who's a personality."

Several state executives have also had conversations with members of the vetting team, including Gov. Gretchen Whitmer, of Michigan, who clashed with President Donald Trump over his handling of the coronavirus, and Gov. Gina Raimondo, of Rhode Island, a leader of her party's centrist wing. Gov. Michelle Lujan Grisham, of New Mexico, a former chair of the Congressional Hispanic Caucus, is one of the can-didates from whom Biden advisers have requested private documents, a signal that she is regarded as a serious contender.

where Stacey Abrams, the
