His name is Dr. Kingsley and he first started practicing in Nigeria. He was unable to attend this meeting but she wanted to introduce him to everyone.

There is a new retroviral drug called Sunlenca (Lenacapavir) that has been approved for HIV according to Chris Dowden. It was approved for the treatment of HIV treatment in Combinations with other medications. It is another injectable. At the moment, it is only approved for multi-drug resistant HIV patients, but it is being studied by itself for the use of Prep. If all goes well, it is possible that we may eventually have a once every six months injection used for Prep which is groundbreaking and will provide discretion and privacy to patients.
