C. Membership Committee update from the September 21st, 2023 meeting: Lysette Pérez

- Planning Council and Planning Body Requirement and Expectations Letter Update by HRSA (Please see attached)
- FAQ's Letter on Planning Council and Planning Body Requirement and Expectations by HRSA(Please see attached)
 - Are in compliance with but wanted to bring it forth
 - There are 13 categories and which we have to be in compliance with
 - Went from 10 vacant seats earlier in the year and after everyone is approved by the Board of County Commissioners, there will only be 1 Vacant seat
 - Cant double up
 - Although there are exceptions, there isn't anyone in the Council meets the required Exceptions
 - Have terms limit and Membership rotation
 - Have been working hard to track the attendance of all committees
 - o This council is one of the most lenient bodies
 - It is a requirement to active in at least one committee to retain membership in the CARE Council

D. CARE Council Budget

- Grants Statement of Expense
 - Current budget is \$41,000 allocated into several different categories
 - Encumbered is money set aside that we know is going to be expend
 - Expended is money that has already been spent and have invoices for
 - Balance is what is remaining
 - Halfway through the grant Year and have about \$20,000 to spend
 - There still expenses coming that are not encumbered
 - The budget needs to be readjusted
 - Allocated \$10,000 towards the retreat and its forecasting that it will be fully spent
 - Need to reduce and pullout from money that has not been spent or used
 - Forecasting 6, 662 dollars to be expended in the Members Incentive category
 - o There will be one more order of the gift cards
 - After the purchase, the category will have to be reduced by 1.737.49
 - Had \$5,000 in the CARE Council budget for Travel but was overspent and now is \$10,000
 - Administrative budget was overspent

- Need to anticipate the travel beforehand and get ahead of it
- The Food and Beverage Budget started at \$5,000 but an extra \$1,000 was eventually added
- When the forecast was done, an additional \$4,000 had to be added in order to spend \$800 a month for food and beverages
- Need to readjust
- Should consider not holding meetings during lunch time

 - Ranges of income has changed into a type box so that Federal poverty level can be assessed

 - Dairy should be a branching logic for vegans'
 - Should it be how often they are able to get the prod
 - New Budget amount is as follows- CC Outreach:\$10,000, CC
 Member Incentive: 4,262.41, CC Member Travel: \$10,000, CC
 Food and Beverages: \$7,000, CC Outreach and other: \$1,537.96,
 Needs Assessment: \$8,199.53
