Housing Assistance Programs

- Short-Term Rental Assistance (EHE):
 - Up to 3 months' assistance, advance or arrears payments
 - No requirement to be behind on rent or facing eviction
 - Case managers must specify "EHE rental assistance" when calling in
 - Contact: Contact office or Bianca Murphy for troubleshooting
- Rental Assistance (Ryan White):
 - Unlimited rent amount; 30-day application processing
 - Legal services available for eviction concerns
 - Not restricted to individuals experiencing homelessness
 - Flyers and referral to food bank services encouraged

Budget Challenges

- **EHE Fund Spend-Down:** Difficulty in fully expending current year funds; next year's allocation expected to decrease.
- Funding for Undocumented Clients: Program remains 100% federally funded.

• 2023 HIV Statistics:

- Palm Beach County ranks 5th in new diagnoses but shows a decline
- Trends: ↓ new HIV & AIDS cases | ↑ prevalence (longer lifespans) | ↓ HIV-related deaths
- Care metrics: 75% in care; 66% virally suppressed
- Death rate: 1.8 per 100,000 (among lowest in Florida)
- **Transmission Modes:** Heterosexual contact most common; Black heterosexuals highest priority group

Rising STD Rates in seniors: Comparable to teenage rates; higher among Hispanic & African American senior.

Prevention Strategies:

Promotion of safe sex practices PrEP and doxycycline prophylaxis

• Senior Centers: Expand HIV information and services on-site
