- I. The CARE Council Meeting was called to order at 2:33p.m. by Chair, Mary Kannel, at the Mayme Frederick Building. Roll was taken, a quorum was present. Guests were introduced.
- II. A Moment of Reflection:

- VI. Comments by the Chair: The Chair welcomed Stephanie Jordan to the CARE Council.
- **VII. Public Comments:** There were none.
- VIII. Educational Moment: Patrice Huntley from Compass, Inc. gave a presentation on Cultural Sensitivity. The title of the presentation was "Don't Yack My Yum" meaning "don't knock it if it's what I believe" or "your yack is yours and mine is mine". Although your views or beliefs may be different it doesn't mean that you hate or dislike a person. You should use the opportunity to (learn) give or get something, be an ally.

# IX. Standing Reports & Updates

- A. **Health Care Reform**: There was no one present to give an update.
- B. Legislature Updates: Vicki Krusel was not present to give an update.
- C. **CPP Updates**: Quinn Paton, the Co-Chair of CPP announced that Regina Roberson has retired, Lorenzo Lowe is the Chair. CPP meets every other month. Ms. Patton reported that CPP is broken into 3 committees: 1) prevention in the schools, 2) building on membership, and 3) collaboration.
- D. Part B Report; Patient Care & 4BNWK Report: Mitchell Durant provided the ADAP/Patient Care/Prevention/Surveillance Report and a RW Part B, Patient Care Network and Patient Care Funding Expenditure Report FY15-16 and briefly summarized of each document.
- E. **Surveillance Report**: Psyche Doe provided the Palm Beach County HIV Surveillance Monthly Reports for January and February. Psyche will prepare a handout of the trend over the last 5 years for the next meeting.
- F. **Medicaid Report**: None no local representative.
- G. **PBC Housing Authority—Update on HOPWA**: Mark White reported that HOPWA received an allocation increase of \$190,000 for the grant year that begins October.
- H. **Florida Statewide Consumer Advisory Group (CAG)**: Denise St. Joy reported the next Face to Face will be a joint meeting with C.A.G., PPG and PCPG in Tampa, April 28 and 29. The 2<sup>nd</sup> annual C.A.G. Retreat will be held in September. Support group is still ongoing at FoundCare. There's a C.A.G. meeting tomorrow, March 29.
- I. Part A Report: Geoff Downing announced that the new Health Planner starts on April 11, 2016. We will be posting for a Program Evaluator position, soon. We had a site visit by the RAND Corporation they also visited the HOPWA program office this is for the Data Integration Grant, we are 1 of 8 selected for a follow-up interview.
- J. **Expenditure Report: Membership:** Frank Frank presented the RW GY15 Reimbursements Expenditure Report. Mr. Frank report that there is roughly \$1.8 million to be spent, which about 27% of the awarded agency contracts. He is anticipating approximately \$200,000 -

- \$250,000 to be unspent from the agency contracts. We should be able to spend all of the admin monies, which would align us with what we had for carryover last year roughly \$268,000. Agencies have until the 31<sup>st</sup> (March 31) to submit final reimbursements. We have received GY16 funding for MIA and formula, a little over \$4,000,000 but we are waiting for supplemental funding. Agency contracts are slated to go before the board on April 9.
- K. **Membership:** Kim Enright reported there's nothing outside of what's in the minutes, what we will be voting on today and what Glenn has added to the agenda.
- L. **LPAP:** Chris Dowden reported that LPAP have couple of things being voted on today and they have been having discussions about the work plan for the coming year.

- **A.** Integration Plan: The goal is to have the draft of the chapter for external review by the end of March. The plan is due to the state by May 15.

- **B.** CARE Council Officers Nominations: CARE Council Officer Nomination forms were passed out and members were instruction to turn form in or email them to Shirley. Mary Kannel has termed out for Chair and Don Hilliard has termed out for Treasurer.
